The provision meets requirements

- Safeguarding is prioritised at the setting. Recruitment and induction procedures are robust. Staff are well trained and know how to help to safeguard children from harm.
- Staff know how to build good bonds with children and nurture their confidence. Staff know how to recognise their efforts and help them to feel a sense of achievement.
- The manager understands how to cater for children's interests and levels of development. Provision is in place for a broad range of experiences for children.
- The manager ensures that staff undertake appropriate training to meet the needs of the children they care for. The manager has systems in place to improve staff practice, including daily briefings, regular supervision and professional development.
- The manager values the role of parents and external agencies. Staff ensure that they understand the precise needs of the individual child before they begin to attend.
- The manager shows pride in the community-based service she offers with her team. She knows how to evaluate the quality of the provision and outcomes for children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Afc Social Opps registered in 2016 and is run by Action for Children. It is a community-based group which specifically supports children who have special educational needs and/or disabilities. It operates from 9.30am to midday and 1.30pm to 4pm on Saturdays. The setting employs 16 members of staff, two of whom hold early years qualifications at level 3.
