Summary of key findings for parents

The provision meets requirements

- The childminder understands her role and responsibilities to effectively safeguard children. She has a clear understanding of the procedures to follow should she have a concern regarding a child's welfare.
- The childminder understands the benefits of working in partnership with parents and other professionals. She explains how information will be shared to help to ensure children's individual needs are met.
- The childminder discusses how she would use information from observations and assessments to plan what children need to learn next, based on their interests.
- The childminder explains the importance of opportunities for outdoor play and involving children in outings within the local area, such as visiting the park. She understands the importance of promoting children's health and well-being.
- The childminder shows a good understanding of how to promote children's safety. She demonstrates a good understanding of assessing risks to help ensure that her home is safe.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector looked at, and discussed, a range of records with the childminder, including policies and procedures, evidence of qualifications and her suitability and that of household members.
- The inspector had a tour of the premises and viewed all areas to be used when caring for children.
- The inspector discussed with the childminder how she intends to deliver the educational programmes for children.
- The inspector discussed the childminder's methods for reviewing the quality and effectiveness of her provision.
- The inspector had a discussion with the childminder about her knowledge and understanding of the safeguarding and welfare requirements.

The childminder registered in 2012 and lives in Sutton-on-the-Forest, near York. She operates all year round from 7.30am to 6.30pm, Monday to Friday, except for family holidays. The childminder holds a relevant childcare qualification at level 3.
