Summary of key findings for parents

The provision meets requirements

- The childminder understands her role in keeping children safe. She is aware of the action to take should she ever have concerns about a child's well-being.
- The childminder acknowledges the importance of teaching children good hygiene routines, healthy lifestyles and in setting clear boundaries to help guide their behaviour.
- The childminder effectively reviews her practice. She has taken positive steps to make improvements since her previous inspection.
- The childminder has a good understanding of how children learn and develop. She knows how to observe and assess children's progress to help to identify any gaps and plan for their next steps in learning.
- The childminder acknowledges the importance of building strong partnerships with parents and carers and to share information about their children's progress.
- The childminder is aware of the importance of keeping her knowledge and skills up to date. She attends courses and reads documentation to help to improve her practice.
- The childminder recognises her role in teaching children to respect and value others.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector viewed the areas of the home used by children.
- The inspector viewed relevant documentation, including paediatric first-aid qualifications and public liability insurance.
- The inspector asked the childminder questions throughout the inspection to establish her understanding of the statutory requirements.
- The inspector viewed a range of relevant policies the childminder has in place and had discussions about how they would be implemented.

The childminder registered in 2005 and lives in Frimley Green, Surrey. She operates all year round from 7.30am to 6.15pm, Monday to Friday.
