Summary of key findings for parents

The provision meets requirements

- The childminder strives for continuous development. She attends a wide range of training above mandatory requirements to impact positively on her knowledge and skills.
- The childminder intends to continually observe children and provide a range of quality, age-appropriate resources and activities to support children's all-round progress.
- The childminder plans to extend children's learning and development through a variety of interesting trips and outings within the local community.
- The childminder recognises the value of working closely with parents. She intends to provide care and learning opportunities complementary to those delivered at home.
- The childminder understands the importance of providing healthy and nutritious meals for children. She intends to incorporate children's choices into menu plans, to help them develop a positive attitude to a healthy lifestyle.
- The childminder knows how to identify and report safeguarding concerns and promote children's welfare. She explains her intentions to provide a safe and inclusive setting.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the childminder how she intends to deliver the educational programmes for children and undertake observation, assessment and planning.
- The inspector discussed the policies and procedures with the provider and viewed documentation that she will use when caring for children.
- The inspector toured the areas of the premises used by children and discussed the equipment and toys available.
- The inspector discussed the safeguarding and welfare requirements with the childminder and took into consideration the suitability checks.

The childminder registered in 2004 and lives in Worsley, Manchester. She operates all year round from 7.30am to 6pm, Monday to Friday, except for bank holidays and family holidays. The childminder works with an assistant.
