Summary of key findings for parents

The provision meets requirements

- The childminder has a secure knowledge of safeguarding procedures. He knows how to recognise signs of abuse and how to report concerns to appropriate agencies.
- The childminder understands the importance of self-evaluation and is eager to continue to improve his own practice, through ongoing training.
- The childminder explains the importance of using observations and assessments to learn about children's interests and ascertain their starting points. He describes how he will use these to plan activities, to enhance children's learning opportunities and monitor their progress.
- The childminder is aware of how to promote strong partnerships with parents, pre-school or nursery settings, to provide consistency for children in their learning, development and personal care needs.
- The childminder knows how to help children learn about healthy lifestyles. He knows how to encourage good behaviour and support children's emotional and physical well-being.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector sampled documents, the childminder's training certificates and policies, including safeguarding, nutrition, inclusion and settling policies.
- The inspector discussed with the childminder his plans for self-evaluation and ongoing improvement.
- The inspector discussed with the childminder how he would gain knowledge of a child's starting points and how to plan for children's next steps.
- The inspector assessed the indoor and outdoor environment.
