Summary of key findings for parents

This provision is inadequate

- The managers do not ensure that the environment is consistently free from hazards. They do not ensure each visitor is adequately supervised while using a mobile phone. During the inspection, this resulted in an unsupervised visitor being in very close proximity to children's changing and toilet areas while using their mobile phone.
- Staff do not record children's attendance at the nursery in a timely manner. They are not sufficiently aware of which children are in their care at any one time.
- The provider does not ensure that the staffing arrangements effectively meet the needs of children. Staff report being overstretched in their roles and routine activities often take priority over their interactions with children.
- Staff frequently interrupt children's involvement in activities and their learning. For example, the practice of taking groups of children to the changing area results in children having to wait around and at times they become distressed.
- At times, the pre-school children are not challenged and supported to learn in the best possible ways as some activities are uninspiring and mundane.

It has the following strengths

- Staff in the baby room are caring and attentive. They quickly recognise when babies are tired and need their comforters, and readily provide these.
- Parents speak positively about the nursery and feel their children are adequately prepared for moving on to school.

What the setting needs to do to improve further

Inspection activities

- This inspection was carried out following a risk assessment process.
- The inspector observed staff's teaching and interactions with children, indoors and outside, and spoke to them at appropriate times. The inspector also held a meeting with the provider and business manager.
- The inspector looked at a sample of paperwork, including staff's qualifications and suitability checks. The safeguarding policies and procedures were also seen.
- The inspector observed an adult-planned activity with the provider and held a discussion with her about staff's teaching skills and children's learning.
- The inspector spoke to a number of parents and grandparents, and took account of their views.

Inspection findings

Effectiveness of the leadership and management is inadequate

Safeguarding is ineffective. The provider fails to consistently implement the safeguarding policies and procedures. For example, a visitor was not made aware of the mobile phone policy and was not adequately supervised. Furthermore, during the inspection, potentially hazardous tools and equipment were accessible to children. Staff do not maintain accurate records of children's attendance. This puts children's safety at risk as staff do not know which children are present. However, staff have a clear knowledge of how to recognise signs of potential abuse and how to escalate these concerns in the nursery and to outside agencies. The provider has suitable recruitment procedures to help ensure that staff working with children are suitable to do so. She regularly meets with staff to discuss their practice and tracks the progress children make.

Quality of teaching, learning and assessment requires improvement

At times, children in the pre-school rooms are not challenged in their learning and the provider does not effectively use the skills and experience within her staff team to promote learning. Although ratios are adhered to, staff are overstretched and rely on students or temporary staff to supervise and support children. During the inspection, staff who were unfamiliar with the children's interests and abilities were asked to read stories while key staff completed domestic tasks. Children quickly became restless and lost interest in the stories. At other times, the quality of teaching is better. For example, staff help children to learn how to compare more and less as they count how many girls and boys are present. Younger children learn how to fill and empty containers as they play with sand and water.

Personal development, behaviour and welfare are inadequate

The provider's failure to adequately supervise a visitor using a mobile compromised children's safety and welfare. Furthermore, the weaknesses in maintaining accurate attendance records place children at risk, especially in the event of an emergency. Staff in the toddler room often interrupt children's play, which hinders their learning. For example, they take groups of children to the bathroom area when they do not need changing. This results in children waiting around and they become upset as they have been taken away from activities they were enjoying. Staff provide children with many opportunities for fresh air and exercise. Older children enjoy activities such as ball games, and babies enjoy exploring the sensory garden.

Outcomes for children require improvement

Children do not consistently receive support to make the progress of which they are capable. Despite this, older children develop skills they need for their move to school. They use pencils well to draw pictures with precise detail and are able to write their names. Babies enjoy exploring what happens when they bang toys together or they drop them on the floor. Toddlers are learning how to use simple technological toys. For example, they ask staff to smile as they use pretend cameras to take their photograph.

The Haven 2000 Nursery and Preschool registered in 2000. The nursery employs 18 members of staff. Of these, 17 hold appropriate early years qualifications at level 2 and above. The provider holds early years professional status. The nursery opens Monday to Friday, all year round. Sessions are from 7am until 6pm. The nursery provides funded early education for two-, three- and four-year-old children.
