Inspected under the social care common inspection framework

Information about this children's home

The privately owned home is registered to care for up to three young people who may have emotional and behavioural difficulties. There has been no registered manager since 30 August 2016.

Inspection date: 12 June 2018

This monitoring visit

On the 24 April 2018, Ofsted completed a full inspection that judged the home inadequate. Ofsted issued a restriction of accommodation notice. The purpose of this monitoring visit was to review compliance with the notice. The other requirements issued at the full inspection were not reviewed as part of this monitoring visit. However, consideration has been given to the progress made in improving the quality of care for young people.

The registered provider has fully complied with the restriction of accommodation notice. No young people have been admitted to the home.

Since the last monitoring visit, the remaining young person has been discharged from the home. The young person moved to semi-independent provision, in line with the placing authority plan. The acting manager has contacted the young person since she moved from the home to support her transition to her new placement.

Risk assessments were reviewed at this monitoring inspection. The acting manager retains responsibility for completing and reviewing the risk assessments. Though the risk assessments clearly set out strategies to manage and reduce risk-taking behaviour, they have not been reviewed in line with the home's procedures. Also, the acting manager could not demonstrate how he had ensured that staff were aware of the strategies in place to support and keep the young person safe.

The acting manager has continued to oversee improvements to the decor of the

home, and the decorators have almost completed redecorating the house. However, young people's bedrooms have yet to be adequately furnished. The acting manager confirmed that new furniture would be purchased before young people were admitted to the home.

(Regulation 6(1)(a)(b) and (2)(c)(i)) <p>This particularly refers to repairing the damaged cupboard door upstairs, ensuring that the driveway is level and safe to drive on and redecorating damaged walls and paintwork.</p>	20/07/2018

<p>The protection of children standard is that children are protected from harm and enabled to keep themselves safe. In particular, the standard in paragraph (1) requires the registered person to ensure that staff— assess whether each child is at risk of harm, taking into account information in the child’s relevant plans, and, if necessary, make arrangements to reduce the risk of any harm to the child; help each child to understand how to keep safe; have the skills to identify and act upon signs that a child is at risk of harm; take effective action whenever there is a serious concern about a child’s welfare. <p>The leadership and management standard is that the registered person enables, inspires and leads a culture in relation to the children’s home that— helps children aspire to fulfil their potential; and promotes their welfare. In particular, the standard in paragraph (1) requires the registered person to— lead and manage the home in a way that is consistent with the approach and ethos, and delivers the outcomes, set out in the home’s statement of purpose; ensure that staff work as a team where appropriate; ensure that staff have the experience, qualifications and skills to meet the needs of each child; understand the impact that the quality of care provided in the home is having on the progress and experiences of each child and use this understanding to inform the development of the quality of care provided in the home; use monitoring and review systems to make continuous improvements in the quality of care provided in the home. <p>The care planning standard is that children— receive effectively planned care in or through the children's home; and have a positive experience of arriving at or moving on from the home.</p> <p>In particular, the standard in paragraph (1) requires the registered person to ensure— that the child's placing authority is contacted, and a review of that child's relevant plans is requested, if— the registered person considers that the child is at risk of harm or has concerns that the care provided for the child is inadequate to meet the child's needs; the child is, or has been, persistently absent from the home without permission. (Regulation 14(1)(a)(b) and (2)(e)(i)(ii))</p>	20/07/2018
<p>The registered person must compile in relation to the children's home a statement ('the statement of purpose') which covers the matters listed in Schedule 1.</p> <p>The registered person must— keep the statement of purpose under review and, where appropriate, revise it; and notify HMCI of any revisions and send HMCI a copy of the revised statement within 28 days of the revision. (Regulation 16(1) and (3)(a)(b))</p>	20/07/2018
<p>The Regulatory Reform (Fire Safety) Order 2005 applies to the home— the registered person must ensure that the requirements of that Order and any regulations made under it, except for article 23 (duties of employees), are complied with in respect of the home. (Regulation 25(2)(b))</p> <p>This particularly refers to ensuring that the fire risk assessment is reviewed and fire extinguishers are stored and located appropriately.</p>	20/07/2018
<p>The registered provider must appoint a person to manage the children's home if— there is no registered manager in respect of the home. If the registered provider appoints a person to manage the home, the registered provider must, without delay, give HMCI notice of— the name of the person so appointed; and the date on which the appointment takes effect. <p>If the registered provider is an organisation, the organisation must ensure that the responsible individual undertakes such continuing professional development as is necessary to ensure that the responsible individual has the skills needed for supervising the management of the home. <p>The registered person must recruit staff using recruitment procedures that are designed to ensure children's safety. (2) The registered person may only— employ an individual to work at the children's home; if the individual satisfies the requirements in paragraph (3). (Regulation 32(1) and (2)(b))</p>	20/07/2018
<p>The registered person must ensure that all employees— receive practice-related supervision by a person with appropriate experience. (Regulation 33(4)(a)(b))</p> <p>This particularly refers to ensuring that the manager of the home is supervised by a person with the necessary skills and experience.</p>	20/07/2018
<p>The registered person must maintain records ('case records') for each child which— include the information and documents listed in Schedule 3 in relation to each child. (Regulation 36(1)(a))</p> <p>This particularly refers to ensuring that local authority care plans are on file and followed in practice.</p>	20/07/2018
<p>The registered person must complete a review of the quality of care provided for children ('a quality of care review') at least once every 6 months.</p> <p>The system must provide for ascertaining and considering the opinions of children, their parents, placing authorities and staff. (Regulation 45(1) and (5))</p>	20/07/2018

Recommendations

- Any staff member who is in charge of leading a shift should have substantial relevant experience of working in a children's home. ('Guide to the children's homes regulations including the quality standards', page 54, paragraph 10.21)
- Any home using monitoring equipment should have a written policy describing how this will support the safeguarding and well-being of those living in the home in accordance with regulation 24. ('Guide to the children's homes regulations including the quality standards', page 16, paragraph 3.16)
