Information about this children's home

The home is registered to provide care for three children up to the age of 18. The home offers care for children who have social and/or emotional difficulties. The home is privately owned.

The manager has been registered with Ofsted since June 2017.

This inspection

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged requires improvement to be good at the last full inspection. At the interim inspection, Ofsted judges that it has declined in effectiveness.

This inspection took place after anonymous concerns were raised with Ofsted about the safety of children, the sufficiency of staffing and the physical condition of the home.

Significant shortfalls were found as a result of this interim inspection:

Managers told the inspector that they were unable to keep one child safe. However, they have not sufficiently escalated their concerns to the placing authority. Managers have failed to take further action when there has been no response from the placing authority about increasing staffing to help to reduce the risks posed to one child. In addition, managers have failed to adequately

challenge the placing authority when return home interviews have not been carried out when a child has returned from being missing from care. This has left one child at significant risk of harm.

- Managers have failed to update children's risk assessments and to provide staff with enough guidance on how to manage and reduce risks effectively. For example, one child's risk assessment has not been updated to reflect that the child managed to steal a car.
- Managers have not made sure that they have adequate staffing to meet the children's needs.
- No action has been taken to address the environmental shortfalls found at the last inspection. A slow response from managers to improving the physical condition of the home has resulted in a further decline in standards. For example, the lounge has an unpleasant smell because there has been a water leak from a bathroom which has soaked into the lounge ceiling. Staff told the inspector that the leak had caused the electricity to go off and that water had managed to get into a smoke detector. Managers have been too slow in getting a competent person in to check that the electrical system is safe. In addition, managers have not investigated the cause of leak; they were not sure if it had come from the toilet or the bath. This failure to investigate has put children at risk of harm. It has taken these concerns to be raised by Ofsted before any action has been taken to make the environment safe.

On the day of this interim inspection, some of the requirements from the last full inspection remained within the timescale for completion. Consequently, this visit has considered the progress that staff and managers have made towards meeting these requirements, rather than whether requirements are met:

- Staffing rotas are now clear about the specific times that staff are on duty. However, when changes to the staffing occur this is not always recorded on the rota. This means that rotas are not clear about who has been in contact with children should this information be needed in the future.
- Staff have still not ensured that they have a copy of a child's annual health assessment. This means that staff do not have access to all the available information needed to inform them about children's health needs.
- Records of physical intervention continue to not meet regulation. For example, one record did not specify the methods used to hold one child on a bed. Records are not clear about how de-escalation techniques are used or when children are spoken to after being involved in a physical restraint. There remains a lack of managerial oversight of physical intervention records. This means that managers do not have a clear understanding of whether staff practice is promoting the safety and welfare of children.
- Progress in ensuring that staff have regular reflective supervision is slow.



Difficulties with access have meant that staff have been delayed in making use of a new online training suite. However, the manager has implemented a revised induction programme to help to improve the knowledge and development of new staff.

■ The manager has increased his oversight of the administration of medication and has introduced a new recording system.

One new concern was found at this visit:

■ The registered manager has not ensured that fire safety arrangements in the home are reviewed and that practice promotes children's safety. For example, the manager has not ensured that a timely review of the home's fire safety risk assessment has been completed. Furthermore, staff did not have access to a master key to be able to access one child's bedroom during the inspection. Ofsted made a referral to the fire authority during the inspection. The inspector was also shown a window in a child's bedroom that had been screwed shut.

Despite the shortfalls found at this inspection, one child continues to do well at college and is enjoying sports coaching. Another child has better arrangements about spending time with their friends. This has helped to significantly reduce the number of times she goes missing from home.

Information about this inspection

Inspectors have looked closely at the experiences and progress of children and young people. Inspectors considered the quality of work and the differences made to the lives of children and young people. They watched how professional staff work with children and young people and each other and discussed the effectiveness of help and care provided. Wherever possible, they talked to children and young people and their families. In addition, the inspectors have tried to understand what the children's home knows about how well it is performing, how well it is doing and what difference it is making for the children and young people whom it is trying to help, protect and look after.

This inspection focused on the effectiveness of the home and the progress and



experiences of children and young people since the most recent full inspection.

Using the 'Social care common inspection framework', this inspection was carried out under the Care Standards Act 2000 to assess the effectiveness of the service, how it meets the core functions of the service as set out in legislation, and to consider how well it complies with the Children's Homes (England) Regulations 2015 and the 'Guide to the children's homes regulations including the quality standards'.
