Summary of key findings for parents

This provision is good

- The manager and staff are very successful in supporting the children's emotional development. For example, staff offer children cuddles and praise them, and build on their developing self-esteem extremely effectively.
- Children develop great self-confidence and engage in activities for long periods. For example, children persevere when they attempt to complete puzzles.
- Children learn about the world around them effectively. For example, they watch the bird house in the garden and use magnifying glasses to explore and hunt for bugs.
- Children are well supported by the manager and staff to learn skills that will help them in the future. All children make good progress.
- The manager and staff are very good role models and children's behaviour is excellent. They provide an extremely warm and nurturing environment where children's views are hugely valued and respected.
- The manager regularly considers the views of staff, parents and children to help her initiate improvements. For example, children 'vote' on the activity of the day.

It is not yet outstanding because:

- Sometimes, staff do not gather enough information from parents about children's prior learning to allow them to plan for children's progress immediately.
- The manager does not consistently organise staff as effectively as possible to help improve the quality of practice to an outstanding level.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- strengthen the ways to obtain initial information from parents about children's prior learning
- enhance the organisation of staff to help to extend the quality of teaching practice to an outstanding level.

- The inspector viewed the premises and sampled documentation.
- The inspector observed the manager and staff interacting with children.
- The inspector interviewed the manager and carried out a joint observation of an activity with the manager.
- The inspector spoke to children and observed activities.
- The inspector spoke to parents and took account of their views.

Inspection findings

Effectiveness of the leadership and management is good

The manager effectively supports staff and identifies any training needs to develop their skills and knowledge. For instance, after training, staff are now better able to manage children's behaviour more effectively. The manager and staff have good partnerships with other professionals and schools that children attend. For example, staff use the same language programme as the local school for continuity of children's learning. The manager and staff share information well with parents. For instance, staff share a 'lending library' and reading tips with parents to continue children's learning at home. Since the last inspection, the manager provides more opportunities for children to be independent. Children enjoy performing small tasks on their own, such as choosing their own snack and pouring their own drinks. Safeguarding is effective. The manager and staff know what to do if they have a concern about a child's welfare.

Quality of teaching, learning and assessment is good

The manager and staff teach children good mathematical skills. Older children begin to measure, and recognise number and quantity. Younger children learn to count and name colours. Staff extend children's learning well. For example, children are encouraged to understand what 'zero' represents. The manager and staff teach children about technology effectively. For example, children use a simple computer program and use a mouse to dress characters on screen. They know to 'click' the mouse and move an item. The manager and staff provide lots of interesting and stimulating activities. For example, children play 'dough disco' and mould and press the dough while dancing and moving to music. Children play with drainpipes in the outdoor environment. They move them and learn that a steeper angle will make cars move faster down the drainpipe.

Personal development, behaviour and welfare are outstanding

The manager and staff teach children about safety exceptionally well. For example, children know how to use scissors safely and understand it is dangerous to walk around the room while holding them. They learn to resolve minor conflicts very successfully by themselves. For example, in a disagreement about a toy, children suggested a 'swap' with one similar. The manager and staff teach children about healthy eating practices exceptionally well. For example, children learn that milk is good for their bones and teeth. They learn about the role of a dentist. Staff use a plastic model of a mouth and teeth to show children how to clean their teeth effectively.

Outcomes for children are good

Children learn to be extremely kind and thoughtful. They develop excellent attachments to staff and each other. Children are developing very good social skills. For instance, they compliment each other's appearance. Children learn how to keep themselves safe. For example, older children explain how small toys can be dangerous to babies. Children have lots of opportunities to develop their physical skills in the very well-resourced and large outdoor area. They climb, ride bicycles and develop their balance, negotiating an obstacle course.

Young Explorers @ Cobham registered in 2013. It operates from purpose-built premises located within Saint Andrews School in Cobham, Surrey. The nursery employs six members of childcare staff. Of these, five hold appropriate early years qualifications at level 3 and one holds a qualification at level 2. The nursery opens Monday to Friday from 7.30am to 6.15pm, during term time only. It provides funded early education for three- and four-year-old children.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
