Summary of key findings for parents

The provision meets requirements

- The childminder has a thorough understanding of her duty to safeguard children. She ensures that her assistant completes all relevant training and regularly updates him on local procedures to follow to promote children's welfare.
- The childminder values partnership working with parents and schools that children attend. She understands how important this is in helping to meet children's individual needs and in supporting continuity in their learning and development.
- The childminder understands the importance of self-evaluation to continually improve the quality of provision. She regularly reflects on the quality of the activities she delivers and identifies opportunities to promote children's learning even more effectively.
- The childminder describes how she manages children's behaviour positively and helps them to learn to respect each other's views. She places high priority on supporting children's emotional well-being.
- The childminder has a good understanding of how children learn. She provides a range of toys and resources and plans effectively to support children to make good progress.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children.
