Summary of key findings for parents

This provision is good

- The childminder provides children with a welcoming, family environment. Children form close attachments with the childminder. This has a positive effect on their emotional well-being. The childminder responds sensitively when children need comfort or reassurance. Children demonstrate that they feel happy, safe and secure in the childminder's care.
- The childminder organises her home efficiently and children access the areas and resources safely. She supervises children well and makes regular checks of her home to ensure all areas used by the children are safe and suitable.
- The childminder has a good understanding of how children learn. She makes regular observations of what children can do. The childminder supports children's play and learning well to help them make good progress in readiness for school.
- Children have daily opportunities for exercise and fresh air in the childminder's garden or on trips to places in the community, such as the park. These help to promote children's good health and support their physical development.
- The childminder helps to extend children's social skills and confidence. For example, she regularly attends local groups with the children.

It is not yet outstanding because:

- The childminder does not engage all parents effectively enough in their children's leaning to promote better consistency between the setting and home.
- At times, the childminder does not fully support children's early literacy skills.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- encourage all parents to be fully involved in their children's learning and share what children learn at home
- provide a wide range of interesting opportunities to inspire children's interest in early reading and writing.

Inspection activities

- The inspector observed the quality of teaching during activities indoors and outdoors and assessed the impact this has on children's learning.
- The inspector spoke with the childminder at appropriate times during the inspection. She looked at relevant documentation and children's records and discussed the childminder's policies and procedures.
- The inspector completed a joint evaluation of an activity with the childminder.
- The inspector checked evidence of the suitability of the childminder and those living on the premises.
- The inspector spoke with the children during the inspection.

Inspection findings

Effectiveness of the leadership and management is good

The childminder understands her responsibility to keep children safe from harm. The arrangements for safeguarding are effective. The childminder has a good understanding of safeguarding procedures. She has attended training to ensure that she can protect children and knows the appropriate action to take should she have a concern about the welfare of a child. The childminder shares her policies and procedures with parents, which provides them with the reassurance that their children are safe and well cared for. Systems for self-evaluation helps identify the strengths and weaknesses of the setting. The childminder keeps her knowledge up to date. She has regular discussions with other childminders and attends training courses whenever possible to develop her own skills and improve outcomes for children.

Quality of teaching, learning and assessment is good

Children are confident to lead their own play. They are inquisitive as they actively explore the wide range of toys and resources. For example, children enjoy investigating how things feel as they experiment with water and bubbles. The childminder gets down to children's level as they play alongside each other. She joins in enthusiastically with their play experiences and this enhances their enjoyment. The childminder talks to children and takes opportunities to extend their learning and development. For instance, she names different colours as children select large blocks. The childminder skilfully questions children to build on what they already know. She uses opportunities well to incorporate number into children's play.

Personal development, behaviour and welfare are good

The childminder asks parents to provide information about their children when they first start at her setting. She follows children's routines to promote continuity of care. The childminder provides clear guidance for children about what is acceptable behaviour. She supports children to learn how to share and take turns. The childminder praises children often and recognises their efforts and achievements. This enables children to develop their confidence and sense of self-esteem. The childminder helps children to learn about the importance of healthy lifestyle choices. She supports children to prepare emotionally for the next stage in their learning. For example, they become familiar with other settings when they accompany the childminder to collect children from school.

Outcomes for children are good

Children gain the many skills they need in preparation for their future learning, such as moving on to nursery or school. For example, they develop their independence as they select the items they wish to play with. Children experience sociable mealtimes and learn to feed themselves with spoons. They enjoy opportunities to develop their physical skills. For example, as children carefully negotiate the low step down into the garden. They eagerly throw and kick large balls and build towers.
