Summary of key findings for parents

This provision is outstanding

- The manager and staff are highly committed to providing children with excellent care and learning. They continually review and adapt the provision superbly to provide the very best experiences for children.
- Children eagerly join in with activities and make outstanding progress from their starting points. All groups of children are exceptionally well prepared for the next stage in their learning, including starting school.
- Staff are extremely skilled in motivating and engaging children during their self-initiated exploration and discovery, to superbly extend their critical thinking. For example, older children are thoroughly absorbed as they investigate which objects float in a tray of water. They experiment and work out how much more water they need to fill the tray, showing excellent problem-solving skills.
- Children benefit greatly from the excellently organised environment which stimulates children to explore in the superb and highly focused activities. For example, younger children investigate enthusiastically with staff to learn how to make patterns and shapes using brushes and water.
- Extremely strong partnerships with parents and other professionals contribute towards children's excellent progress. Staff gain excellent information about what children can already do to inform their meticulous assessments of children's learning and progress.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

continue to enhance the exceptional planning system to maintain the excellent standard of teaching.

Inspection findings

Effectiveness of the leadership and management is outstanding

Safeguarding is effective. The manager ensures that staff have an excellent awareness of their responsibility to protect children. She follows clearly detailed recruitment and employment processes to fully assess and monitor the ongoing suitability of staff. The manager supports staff extremely well in their ongoing professional development to benefit children's needs. For example, following the previous inspection, staff have learnt how to further adapt the learning environment to provide highly exciting exploration and discovery challenges indoors and outdoors. The manager quickly identifies any gaps in learning and ways to help children catch up, using highly efficient systems, to ensure all children make the best progress. She is extremely committed to implementing improvement plans, such as using better techniques of capturing moments of spontaneous children's learning to inform future plans and enhance learning further.

Quality of teaching, learning and assessment is outstanding

Staff use training very effectively and their exemplary knowledge of how children learn. They meticulously observe and provide exactly the right expert support so children's play is long lasting. For example, children learn that a football is a sphere shape and staff request that they find other sphere objects in the environment. Staff provide outstanding support for children to make decisions and extend their ideas. For example, after learning about the sound the letter 'P' makes, older children chose two objects that begin with the letter 'P', and make up a story to share with others using the items. Staff expertly extend children's vocabulary and communication skills. Toddlers take great pleasure playing in the spacious and highly stimulating outdoor play areas. For example, they very enthusiastically enjoy painting outdoors, learning about mixing and making different colours and playing with real foods in an outdoors kitchen to enhance their sensory play.

Personal development, behaviour and welfare are outstanding

Children are extremely confident. They freely explore the highly stimulating resources and activities in the very vibrant and safe environment. Children benefit from the excellent settling-in procedures, where staff consider their individual needs exceptionally well. Children have very high self-esteem. For instance, in Spanish, they eagerly express their expert knowledge of different colours with others. Children have excellent relationships. Staff very skilfully help them learn about the feelings of others and different emotions, for example, by using picture cards showing different feelings. Staff lay excellent foundations for children to adopt healthy and safe lifestyle habits, and for developing a secure respect for the beliefs and traditions of others.

Outcomes for children are outstanding

Children use mathematics exceptionally well throughout their activities and develop excellent early reading skills. They display extremely high levels of concentration and cooperation. Children work together exceptionally well and become highly engrossed in the activities. They are extremely imaginative. Children gain an excellent sense of satisfaction through their investigations and thinking things through logically.

Dell Cottage Day Nursery is privately owned, and registered in 2005. It operates from a converted house in Walkford, an area of Highcliffe, in Dorset. The nursery opens Monday to Friday, all year round from 8am until 6pm. There is currently a team of seven staff, who work with the children. Of these, five hold early years qualifications at level 3 and the manager also has early years professional status.
