Summary of key findings for parents

This provision requires improvement. It is not yet good because:

- Although the childminder reviews most aspects of her provision, she has not fully considered the potential risks to children while they play on a trampoline. She has taken steps to address actions raised at the last inspection.
- Children do not have the opportunity to develop their awareness of people and communities beyond those familiar to them, including those people with different physical characteristics.

It has the following strengths

- The childminder shares her written complaints procedure with parents and displays the contact details for the regulator.
- The childminder plans effectively for children. She works closely with other professionals involved in children's lives and shares information to ensure children receive effective support to maintain their learning.
- The childminder undertakes professional development opportunities to continually enhance her skills. She uses these to ensure activities motivate and challenge children.
- Children form close relationships with the childminder and their peers. They enjoy sharing information about their day with the childminder and each other.
- Children behave well. They use their manners well and show respect towards each other. The childminder praises children's efforts and achievements. She builds their confidence and self-esteem.

What the setting needs to do to improve further

To meet the requirements of the early years foundation stage and the Childcare Register the provider must:

- The inspector spoke to parents during the inspection and took account of their views.

Inspection findings

Effectiveness of the leadership and management requires improvement

Arrangements for safeguarding are effective. The childminder is aware of potential risks to children and generally minimises these appropriately. For example, she removed damaged netting from the trampoline in the garden because she deemed it to be dangerous to children. However, she has not fully considered minimising all other risks linked with children jumping on a high-level trampoline. Security is good and children cannot leave her home unsupervised. The childminder understands her role in protecting children from harm and neglect. She is fully aware of the referral process to ensure children in her care remain safe. Partnerships with parents are secure. Daily communication takes place so they are aware of their child's experiences each day.

Quality of teaching, learning and assessment is good

The childminder plans a variety of activities for all children as they arrive after their day in Reception class in school. She shares information with other professionals, such as teaching staff, and uses information they share to help support children's learning in her home. The childminder uses her observations of children's abilities to help her plan a wide range of play opportunities. Children are self-assured individuals and eagerly engage in activities. They share their own ideas and confidently ask for specific activities, especially those that encourage their creativity. For example, they enthusiastically choose paints and decorate different sized stones to decorate the garden. They enjoy mixing paints and preempting what colour they will make and talk about the differing shades of colours. The childminder effectively supports children's language and communication skills. She asks children questions and encourages them to share their ideas and talk about what they are doing. Children create their own stories with the childminder and draw pictures to illustrate these. They use their imaginations well and engage in role play and recreating familiar experiences.

Personal development, behaviour and welfare require improvement

Failure to fully minimise all potential risks outdoors means that children's overall safety is not fully addressed. However, the area is used effectively to help children extend their physical skills. Children play games, such as tennis and skittles, and learn the importance of taking turns. They also learn about their own safety as they walk to and from school and learn to use equipment safely at the park. Children learn respect for the views of others. They learn about democracy and vote about activities, such as visiting the park. The childminder encourages children to think about the feelings of other children and they learn to negotiate when playing. They enjoy healthy snacks and follow clear hygiene routines. They understand why they need to wash their hands before meals.

Outcomes for children are good
