The provision meets requirements

- Staff understand their role in keeping children safe and protecting them from risk of harm. They are aware of the action to take if they ever have concerns about a child's well-being.
- Staff understand the importance of teaching children good hygiene routines, healthy lifestyles and setting clear boundaries to help to guide their behaviour.
- Leaders are committed to their role. They use effective methods to evaluate the provision, such as quality-improvement programmes and seeking the views of other professionals to help to drive for improvement continuously.
- Staff have good opportunities to extend their knowledge and skills, for example, through attending training and regular supervision discussions with leaders.
- Staff demonstrate a good understanding of the importance of providing activities to help children to build on their physical, social and creative skills.
- Leaders recognise the importance of working in partnerships with parents and other settings that children attend, to help to provide continuity of care for children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
