# Summary of key findings for parents

## This provision requires improvement. It is not yet good because:

- At times, staff do not focus well on meeting children's individual learning needs, including those who have special educational needs (SEN) and/or disabilities. They sometimes overlook opportunities to challenge children or provide additional support to help them make better progress.
- Leaders and managers are supporting new and existing staff during a time of change. However, their monitoring and supervision procedures do not currently ensure good learning outcomes for all children.
- Leaders, managers and staff do not identify and address weaknesses in the quality of teaching and learning sufficiently well, and their practice requires improvement to be good.

## It has the following strengths

- Children throughout the nursery are settled and show good levels of behaviour. They respond well to staff, and are familiar with routines and safety rules. Most children engage well in their play and enjoy exploring the learning environment.
- Staff have a kind and caring nature, and they develop positive relationships with children and their parents.
- Staff understand safeguarding procedures and work appropriately with relevant agencies to share information and support families where necessary.

## What the setting needs to do to improve further

## **Inspection findings**

## Effectiveness of the leadership and management requires improvement

Safeguarding is effective. Staff supervise children well and follow established safety procedures to help keep them safe. They receive regular support and training to help them understand safeguarding procedures. The designated safeguarding lead understands her responsibility to assess and refer concerns where necessary. Leaders and managers ensure that appropriate numbers of suitable and qualified staff are available to care for children. They provide some supervision and training for staff but this is not effective to ensure that all children have good learning experiences consistently. Leaders, managers and staff welcome feedback from parents and children but do not address weaknesses successfully in some areas of practice.

## Quality of teaching, learning and assessment requires improvement

Staff assess children's progress regularly from when they start in the nursery and share their findings routinely with parents to keep them well informed. They sometimes support children's learning well. For example, staff encourage physical development and confidence as they help children to climb steps and jump safely. However, the quality of teaching is inconsistent. Staff sometimes do not encourage and challenge children's thinking effectively. This is apparent when children are not able to explore shape, space and measures in a way that really challenges their thinking in preparation for their next stages and for school.

## Personal development, behaviour and welfare are good

Staff are good role models and help children to manage their behaviour effectively overall. They encourage independence and help children to become confident. For example, they support children well to help themselves to food and drink at mealtimes. Staff embrace children's different cultural backgrounds and help them to respect each other. They take care of children's welfare needs and demonstrate this when they prepare carefully for outdoor play in hot weather. Staff ensure that children are able to sleep and rest when they need to, and they support toileting needs effectively.

## **Outcomes for children require improvement**

All children make some progress and develop some skills. Most children have a positive approach to learning. For example, children enjoy singing and sharing stories, which encourages their communication and language development, including those who speak English as an additional language. However, the lack of challenge and support at times means that children do not access high-quality learning experiences consistently. Sometimes children who have SEN and/or disabilities do not receive good-quality support, although staff do work in partnership with external agencies to follow some agreed strategies.

Tigers Too Day Nursery is one of four nurseries run by Tigers Too Day Nursery Ltd. It registered in 2004 and operates from four rooms in a two-storey building in the centre of Thatcham, West Berkshire. The nursery is open on weekdays from 7.45am to 6.15pm throughout the year. It receives funding for the provision of free early education for children aged two, three and four years. The nursery employs 16 staff, and 14 of these hold relevant qualifications at levels 2, 3 or 5.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
