Summary of key findings for parents

The provision meets requirements

- The childminder understands her duty to keep children safe and to notify Ofsted of anything that may affect her suitability. She knows how to recognise indicators that a child may be at risk of harm and how to refer any concerns about a child's welfare. The childminder has a current paediatric first-aid certificate.
- The childminder understands the learning and development requirements of the early years foundation stage. She knows how to monitor and assess children's learning and how to plan activities to build on what children know and can do.
- The childminder provides a suitable environment for children's care. She understands the importance of working in partnership with parents and others involved in children's care, to meet their needs effectively.
- The childminder has carefully considered how she will evaluate her provision to maintain continuous improvement.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector viewed the premises, including the outdoor area and the resources that will be used for childminding.
- The inspector looked at policies and documents the childminder will use when caring for children.
- The inspector discussed with the childminder how she intends to deliver educational programmes for children.
- The inspector discussed with the childminder how she plans to evaluate her provision and how she has addressed the recommendation made at the last inspection.
- The inspector checked the evidence of the suitability of the childminder and other adults in the household.

The childminder registered in 2010. She lives in Feltham, in the London Borough of Hounslow. She operates her service Monday to Friday, from 7.30am to 6pm, for 48 weeks of the year. The childminder holds a relevant early years qualification at level 3.
