## Summary of key findings for parents

### The provision meets requirements

- The childminder demonstrates a good knowledge of her responsibilities associated with safeguarding. She knows how to swiftly identify and report any child protection concerns.
- The childminder provides a wealth of age-appropriate resources to stimulate children's learning. She intends to observe children and to plan a range of exciting activities to support all-round progress.
- The childminder explains she intends to enrich children's learning experiences through a mix of self-chosen games and adult-led activities, both indoors and outside.
- The childminder understands the importance of providing nutritious snacks and meals to promote children's health.
- The childminder plans to work closely with parents to provide continuity for children in their care and learning. She intends to provide a welcoming and inclusive setting.
- The childminder has established links with other settings, to help to share good practice ideas. She intends to evaluate her practice and drive ongoing progress.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children.
