Summary of key findings for parents

The provision meets requirements

- The manager ensures that staff check the premises and resources regularly to support children's safety. They explain that they make resources and equipment for children accessible to help promote children's independence.
- The manager supports staff to understand how to promote children's healthy lifestyles. They discuss the importance of providing children with a variety of balanced snacks and understand the benefits of physical play.
- The manager explains that staff work with parents and the host school, to help promote continuity of care and learning for children, and to support their emotional well-being.
- The manager supports staff so they understand how to manage children's behaviour positively, according to their individual stages of development.
- The manager and staff understand their role and responsibilities to protect the children's welfare. Through discussion, they demonstrate they know to take action to help keep children safe from abuse or neglect.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the manager how they complement the educational programmes used in school when children are present.
- The inspector discussed the policies and procedures with the provider and viewed documentation used when caring for children.
- The inspector checked evidence of staff qualifications and their suitability to work with children. She discussed methods used to self evaluate.
- The inspector discussed issues relating to the management of safeguarding children within their care.

Luddendenfoot Out of School Club registered in 2001. The club employs four members of childcare staff. Of these, three hold appropriate early years qualifications at level 2 or above. The club is open Monday to Friday from 7.30am to 9am and 3.15pm to 6pm term time only.
