Summary of key findings for parents

This provision is good

- The childminder successfully evaluates her practice. She gains the views of parents and other professionals, such as childminders, to determine what works well and what changes to make to her practice. She has clear aims for the future, including introducing more natural resources into children's play.
- Children make good progress in their learning and development. The childminder observes children regularly and uses this information to identify their next steps and plan challenging activities to build on their existing skills and knowledge.
- The childminder engages in conversation with children effectively. For instance, she asks them questions to encourage them to think and explore why things might happen.
- Children are encouraged to try activities, including those that they find a little challenging. They show good levels of self-confidence and emotional well-being.

It is not yet outstanding because:

- The childminder does not clearly display her registration documents.
- At times, the childminder tends to do things for the children that they could easily do for themselves.
- Training and development opportunities are not as good as they could be, to help the childminder keep her knowledge and skills fully up to date.

Inspection findings

Effectiveness of the leadership and management is good

The childminder is aware of her duty to keep children safe. She meets adult-to-child ratios to meet the individual needs of children. Safeguarding is effective. The childminder has a good understanding of the signs that a child may be at risk of harm. She knows the procedures to follow if she has concerns about a child's welfare. She has developed positive relationships with parents and staff at other early years settings children attend. For example, she completes transition reports when children go to nursery to help staff to meet the care and learning needs of individual children. The childminder has failed to display her certificate of registration; however, this does not have an impact on the care of children.

Quality of teaching, learning and assessment is good

The childminder provides a good range of activities that promotes children's enjoyment and learning effectively. She makes good use of spontaneous opportunities to extend children's learning. For example, when children talk through long tubes, she talks to them about their voices echoing through the tubes and encourages them to compare if the wide or the narrow tube creates a louder sound. Children enjoy their time outdoors and have good opportunities to learn about the world in which they live. For example, they talk about things that they observe, such as a spider that has built its web on one of the outdoor toys. The childminder supports children's mathematical skills well. For instance, she provides activities to help children recognise numbers, count and add quantities together.

Personal development, behaviour and welfare are good

Children work well together. For example, they roll a ball between one another and understand the need to share and take turns. They are happy, content and settled within the childminder's care. They eagerly explore with confidence and complete challenging tasks. For example, they use stilts to walk around the garden and show pleasure when they succeed. The childminder uses positive strategies to manage children's behaviour. For instance, she has clear rules to help children to understand the types of behaviour that are acceptable and those that are not. Children's behaviour is good. They show good levels of self-confidence and have a good understanding of what is right and wrong. Children successfully lead a healthy lifestyle. They enjoy nutritious meals and snacks and engage in plenty of opportunities for fresh air and exercise.

Outcomes for children are good

Children confidently develop skills that prepare them for the next stage in their learning. They show high levels of skills in speaking and listening. For instance, they have discussions with the childminder about their own experiences and family lives and listen with interest. They enjoy listening to stories, accurately predict what will happen next and describe what is happening in the story. Children show a good understanding of simple addition and can sort groups of objects with similar characteristics.
