The provision meets requirements

- The childminder knows how to monitor children's progress and plan for their next steps.
- The childminder understands how to evaluate her provision and identify where to make improvements. She attends training offered by the local authority to improve her safeguarding knowledge and consistently develops her teaching practice.
- The childminder recognises the importance of supporting children's independence and teaching them to manage their personal care needs, in readiness for school. She understands how to help them enjoy healthy and active lifestyles.
- The childminder knows how to teach children about similarities and differences between themselves and others.
- The childminder understands how to form effective partnerships with parents to support children's care and learning needs. She recognises the importance of developing close and caring relationships with children to nurture their confidence and well-being

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation.
