The provision meets requirements

- The provider recognises the importance of working with parents. For example, she aims to collect and share information with parents about their children's time at the camp.
- The provider understands how to observe children and plan age-appropriate play experiences to complement their learning at school. There are suitable toys and resources that are available for children to use.
- The provider knows how to use self-evaluation to reflect on the quality of the provision. She intends to support her own and staff's ongoing professional development.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector viewed the areas to be used for the care of children. She looked at the equipment and toys that will be made available for the children.
- The inspector looked at relevant policies and documents, including safeguarding and risk assessment procedures. She discussed with the provider how she reviews the provision.
- The inspector discussed with the provider how she intends to observe and monitor children's play activities. She discussed with the provider how she plans to support children in the early years age group.
- The inspector checked evidence of the provider's training, including the first-aid certificate and staff's suitability.
