Summary of key findings for parents

The provision meets requirements

- The manager and staff understand how to provide an enjoyable range of activities for all children after school to help complement their day at school.
- The manager recognises the importance of self-evaluation to help them identify any further areas for improvement. She understands the benefits of having effective systems in place to monitor practice and providing staff with regular professional development opportunities.
- The manager is aware of her responsibility to protect children from harm. She ensures staff undertake regular training and understand about wider safeguarding concerns. Staff know the procedures to follow if they have a concern about a child's welfare.
- The manager and staff understand the importance of keeping parents well informed about the time children spend at the club. There are procedures in place to exchange information with parents to identify and support children's individual needs.
- The manager ensures that all staff hold a recognised paediatric first-aid qualification.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector held discussions with the manager about her knowledge of the requirements of the early years foundation stage.
- The inspector looked at and discussed the toys and resources available for children at the after-school club.
- The inspector checked registration and insurance documents, and the staff team's paediatric first-aid qualifications.
- The inspector sampled a range of documents, including those relating to recruitment and staff support, and discussed the manager's range of policies and procedures with her.
- The inspector discussed the manager's process for self-evaluation and her identified areas for improving practice.

Kids Den registered in 2014. The club opens from 7.30am to 8.40am for breakfast and from 3pm to 6pm after school, Monday to Friday, during term time only. A team of six staff are employed; four hold appropriate qualifications in childcare at level 3 and above. All staff hold recognised paediatric first-aid qualifications.
