## Summary of key findings for parents

#### This provision is inadequate

- The childminder regularly cares for five young children, and at times six, and is unable to meet all of their individual needs.
- The childminder allowed alcohol to be consumed on the premises in an area where children were playing.
- The childminder lacks knowledge and understanding of the learning and development requirements. She makes no assessments of children's starting points or of their progress. Planning for their learning and development is inadequate in all areas.
- Activities do not capture children's interest or extend their learning. Children are left to organise their own play from the available toys and opportunities for babies are particularly weak. The childminder does not enthuse or inspire children's play.
- Parents are not provided with enough information about children's progress to become activity involved in their learning.
- The childminder does not identify issues that restrict children's language development and their ability to listen and concentrate. Children are heavily distracted by the two televisions that are on in the living room and playroom throughout the day.
- The childminder fails to identify and target ways to improve her practice and knowledge.

#### It has the following strengths

# **Inspection findings**

#### Effectiveness of the leadership and management is inadequate

Safeguarding is ineffective. The childminder allowed a visitor to the premises to bring a bottle of wine and consume this in the garden while minded children were present. The childminder has been caring for up to six children in the early years age range, including two babies, Monday to Thursday. She has not demonstrated, as is required, to parents and Ofsted that she has sufficient experience and skills to meet the needs of this many children. The childminder has sufficient understanding of the procedure to follow if she is concerned that a child is being abused. The childminder does not work effectively with parents to support children's learning, and demonstrates a lack of motivation and commitment to improving her practice.

#### Quality of teaching, learning and assessment is inadequate

The childminder does not complete any assessments on children, despite receiving local authority funding for some children's early education. Although the childminder completes some observations on children, these are not sufficiently evaluated. She identifies some next steps for learning, such as developing pencil control, but does not provide opportunities for children to practise these. On the day of inspection there was only one brief activity planned for children, to water sunflowers. The childminder did not use this opportunity to extend children's learning. When children initiated their own play, such as with dolls, the childminder did not recognise the distraction caused by the television and play was short-lived. Babies do not receive sufficient stimulation.

#### Personal development, behaviour and welfare are inadequate

The childminder, by allowing visitors to consume alcohol on the premises, is not promoting good health and safety. She does not provide adequate support and encouragement to babies and young toddlers to encourage their self-confidence and self-awareness. The childminder meets children's routine needs, such as for nappy changing and sleep, and she comforts children with cuddles. However, she does not plan or organise time to help children develop independence and play skills. Children learn about some traditions and beliefs from community-based activities that the childminder takes children to; for instance, the local church at Easter.

#### **Outcomes for children are inadequate**

Children are not adequately prepared for their next stage in learning. Their progress in communication and language, mathematics and literacy is not good enough. Babies are not supported to become interested enough in engaging in play or to develop vocabulary.
