# **Summary of key findings for parents**

## The provision is outstanding

- The highly experienced and inspirational manager leads her exceptionally well-qualified staff team with superb efficiency and admirable enthusiasm. The quality of staff's interaction is outstanding. Staff know how to talk to children and get the best out of them.
- Children have an excellent attitude to learning through play. Staff establish a very encouraging and positive environment. They set a very good example and manage behaviour well. Children are calm, friendly and very busy during the session.
- Children develop secure friendships and display high levels of self-confidence and self-motivation. They are tremendously enthusiastic and confident in all that they do.
- Staff highly value children's safety. For example, they undertake regular and thorough checks on the premises and resources to help children manage risks very effectively.
- The staff and management team accurately evaluates the quality of the club's provision and sets a clear direction for future development. Staff listen to children views and regularly involve them in choosing the themes and activities that the club provides. This gives children a very clear sense of belonging.
- Parents speak very highly of the care and the support the staff provide to their children. They feel very well informed about what the club offers and how staff keep their children safe.

# What the setting needs to do to improve further

### To further improve the quality of the early years provision the provider should:

■ continue to enhance the already excellent relationship with parents and find out even more information about the child when they first start.

#### **Inspection activities**

- The inspector observed the activities indoors and outdoors and the interactions between staff and children.
- The inspector talked to staff and children at appropriate times during the inspection.
- The inspector completed a joint observation with the club manager.
- The inspector held a meeting with the club manager and provider. She looked at relevant documentation and evidence of the suitability of staff working in the club.
- The inspector spoke to a number of parents during the inspection and took account of their views.

## **Inspection findings**

## Effectiveness of leadership and management is outstanding

Safeguarding is effective. Staff are exceptionally well trained in all areas of safeguarding and promoting children's well-being. They deploy themselves extremely well and diligently risk assess play areas so children remain safe at all times. Staff use highly effective communication with each other to ensure children are always closely supervised. They confidently demonstrate an excellent understanding of the club's comprehensive policies and know what to do if they have any concerns about a child's welfare. Robust recruitment processes ensure staff's initial and ongoing suitability to work with children. The monitoring of staff practice is excellent. The management team makes excellent use of staff supervision, spot checks and meetings to ensure high-quality experiences for children. Staff are forward thinking and constantly reflect on their practice to quickly identify where improvements can be made.

## Quality of teaching, learning and assessment is outstanding

Children enjoy their time at this lively and vibrant club. Passionate and friendly staff make a significant contribution to children's experience and enjoyment of the club. They are highly skilled, creative and constantly explore new ways to improve children's play. Staff interact with children exceptionally well. They know when to allow them to explore independently and when to join in their play to extend their learning. Staff help children to work cooperatively together. For example, children work together to build up their own obstacle courses, in which to test their physical skills. Children talk enthusiastically about their activities and what they have made in the art and craft activities. They gain a deep understanding of different cultures and learn about a range of festivals, such as Chinese New Year. Staff gather useful information from parents about children's personal needs when they first join the club. However, they do not gather enough really detailed information about children's likes, dislikes and interests to help staff to gain a more indepth picture of each child.

## Personal development, behaviour and welfare are outstanding

Children display an exceptional understanding of themselves and how to keep safe. For example, they talk confidently about the importance of wearing sun cream and a sun hat if they want to play outside. Staff encourage children to regularly drink water to ensure they stay hydrated. They speak calmly to the children and they quickly identify anyone who needs help. Staff are thoughtful and considerate towards individual children's needs. They nurture children's emotional development and support younger children to build on their existing sharing and turn-taking skills. Older children support younger ones and friendships flourish in this harmonious atmosphere of mutual trust and respect.

St Edmund Campion School Holiday Club registered in 2016. It operates from rooms within St Edmund Campion School. The holiday club employs 30 members of staff. Of whom, 10 hold qualified teacher status, 14 hold relevant qualifications at level 6, four hold level 5, one holds level 4 and one hold level 3. The holiday club is open three days a week throughout all the school holidays. Sessions are from 8.30am until 4pm.
