- The childminder does not ensure all documentation is in place as required. This relates to her public liability insurance.
- The childminder has an understanding of what do to should she have a safeguarding concern to ensure children's safety and welfare.
- The childminder knows how to foster positive relationships with parents to ensure they contribute to children's next steps in learning and support continuity of care.
- The childminder understands the benefits of supporting children's good health by planning a range of outdoor pursuits, including places of interest, to support children's interactions with their friends and others.
- The childminder knows how to provide a range of play experiences to support children's learning. She has put in place systems to help her monitor children's progress according to their age and stage of development.
- The childminder understands the benefits of training and evaluating the care and service she provides to support positive outcomes for children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
