Summary of key findings for parents

This provision meets requirements

- The childminder has a secure knowledge and understanding of safeguarding policies and procedures. She has attended various training to update her knowledge of the latest legislation and regulations. The childminder is able to recognise various child protection concerns and knows the correct steps to take to keep children safe.
- The childminder has a good understanding of the early years foundation stage. She knows how to plan a range of activities for children across the seven areas of learning that meet their individual learning and development needs. The childminder has systems to assess and monitor children's progress.
- The childminder understands the importance of providing a safe environment that promotes children's well-being. She knows how to maintain her premises to ensure they are safe and suitable for children.
- The childminder understands the value of developing partnerships with parents and other professionals in maintaining consistency for children.
- The childminder demonstrates a good understanding of how to promote positive behaviour with children. She knows how to teach children about values and respect, and how to help them understand the importance of developing healthy lifestyle.
- The childminder understands the importance of training in improving the quality of the provision for children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector sampled documentation relating to children's care and learning.
- The inspector held discussions with the childminder relating to safeguarding, learning and development and care practice.
- The inspector sampled a range of documents, including records of the childminder's suitability, qualifications, policies and procedures.

The childminder registered in 2005 and lives in Hornchurch in Essex. The childminder operates all year round flexible hours, Monday to Friday, except for bank holidays and family holidays. The childminder holds a relevant qualification at level 2. She works with an assistant on an ad-hoc basis as needed.
