# Summary of key findings for parents

#### The provision is inadequate

- Procedures for monitoring and evaluating the nursery are inadequate. The provider has failed to identify and address all actions raised from the last inspection and subsequent visits. Significant weaknesses and breaches in requirements still remain and the provider shows a poor capacity to improve.
- Significant weaknesses remain for staff performance, induction and supervision, behaviour management, key-person systems, and observations and assessments. These compromise children's well-being and learning.
- The leadership team does not ensure staff fully follow all policies and procedures of the nursery. For example, staff do not record all accidents or incidents to ensure children's welfare.
- Staff put younger children's health at risk of cross-infection because they do not ensure good hygiene practices are maintained.
- The provider fails to ensure that staff complete progress checks for children aged between two and three years. Parents do not receive a written summary of their children's progress, as required.

#### It has the following strengths

- All children have daily opportunities for fresh air and physical activity.
- At the inspection, some parents commented that they have seen some positive changes in the nursery and that, overall, their children separate from them with ease.

### What the setting needs to do to improve further

#### The provision is inadequate and Ofsted intends to take enforcement action:

## **Inspection findings**

#### Effectiveness of leadership and management is inadequate

The provider has failed to make sufficient improvements to the provision since the last inspection. Safeguarding is not effective. Although staff now understand the procedures to follow in the event of a concern, they do not safeguard children well enough. Staff do not manage all children's behaviour appropriately and do not offer reassurance to them to help them feel safe. Poor behaviour often goes unnoticed by staff who take no action to minimise or prevent incidents and accidents happening. In addition, staff do not correct children for hitting, pushing, poking or squealing in the faces of their peers. The management team has offered staff training on behaviour management. However, staff do not put this training into practice adequately, which results in some children being intimidated or hurt by others. The provider has not met all actions raised at the last inspection linking to learning, development and assessment, which means children have poor opportunities for continuous learning. The provider has taken insufficient action to ensure that staff induction and supervision are up to date. For example, newly appointed staff do not have ongoing reviews as per the induction process. Also, not all staff have their action points followed up from previous supervision. This includes improving procedures for reviewing children's learning and assessment to make accurate accounts of the children's development. Furthermore, not all staff follow the nursery's policies and procedures for accident recording to maintain good practice. Therefore, the management team manages ongoing performance poorly. The provider has appointed a deputy manager and has suitable risk assessments in place to ensure that the premises are safe and secure.

#### Quality of teaching, learning and assessment is inadequate

The provider has failed to meet the actions raised at the last inspection. For example, assessments of children's development are not reliable because they have not been updated. Staff do not use the observations and assessments to support children's learning. For example, older children's next steps do not accurately match to their individual needs. In addition, staff do not plan activities linked to younger children's next steps. For instance, they plan for children's exploration for media and materials, even though there are clear gaps in the children's learning for communication and language and personal, social and emotional development. This means that key workers are not focusing on the most important areas of learning. The provider fails to ensure that staff complete progress checks for children aged between two and three years. Therefore, parents do not receive a written summary of their children's progress, as required. In addition, the provider does not have an accurate understanding of staff assessments to inform reviews of children's overall learning. Despite this, some staff provide appropriate activities and offer some positive support to children. For example, older children have opportunities to be creative and babies enjoy and are encouraged to be part of the interactive singing times.

#### Personal development, behaviour and welfare are inadequate

Weaknesses in leadership have a significant impact on children's personal development, behaviour and welfare. Staff operate a key-person system. However, this is ineffective at meeting the needs of all children in the nursery. For instance, when new children attend

for settling-in visits, staff pass them to each other despite the children crying. This does not help children form secure attachments to their key person. Furthermore, staff take older children out of group activities without asking them what they would like to do. The play environment is safe and well maintained, and children enjoy freshly prepared nutritious snacks and meals. However, staff put some babies at risk of infection because they do not ensure they drink from the correct beakers. This compromises their good health. Staff help children to develop their understanding of safety. For example, children practise fire drills and learn what to do in the event of an emergency.

#### **Outcomes for children are inadequate**

Staff fail to support children's learning and progress sufficiently. They do not notice the poor behaviour of some children and the negative impact this has on the enjoyment of their friends. Some children are not motivated to join in with activities, and teaching is not consistent to support children's communication and language. Overall, the poor teaching and support mean that children do not make good enough progress in readiness for school.

Banana Moon Day Nursery Caversham registered in September 2016. It is located in the Caversham area of Reading, in Berkshire. The nursery is open each weekday from 7.30am to 6.30pm, throughout the year, with the exception of one week between Christmas and New Year. The nursery provides free early education for children aged three and four years. The nursery employs 14 staff, of whom, 12 hold relevant childcare qualifications at level 2 or above.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
