# Summary of key findings for parents

Personal development, behaviour and welfare

## The provision is good

- Children make good progress. The childminder promotes children's learning and development well. She skillfully monitors and encourages children's progress and builds on their interests and curiosity.
- The childminder provides a nurturing environment where children settle quickly, and are happy and relaxed. Children confidently explore the resources and interact with the childminder.
- Good regular communication with parents and professionals helps to ensure important information is shared about the children and their progress. Any gaps in learning are investigated and addressed.
- The childminder promotes communication and language, and physical development particularly well. She encourages children to listen attentively and talk about their activities. They show increasing coordination and balance as they use the ageappropriate outdoor equipment.
- The childminder reflects on her work, seeks the views of parents and updates her knowledge regularly to ensure she provides a high-quality provision.
- The childminder is a calm and patient role model. She sets a positive example to children and their behaviour is good.

## It is not yet outstanding because:

Children do not have many opportunities to mix with other children of similar ages or abilities, to extend their social skills and learn from each other.

## What the setting needs to do to improve further

### To further improve the quality of the early years provision the provider should:

increase opportunities for children to have more social interaction with other young children.

- The inspector toured the premises and reviewed the resources with the childminder.
- The inspector observed the children and childminder at play, and discussed their activities.
- The inspector looked at the documents provided by the childminder.
- The inspector considered parents comments about the childminders service.

## **Inspection findings**

## Effectiveness of leadership and management is good

Safeguarding is effective. The childminder supervises children closely and helps them to learn safe behaviours. For example, they learn to walk carefully up and down steps. She risk assesses activities and manages potential hazards effectively. The childminder has a clear knowledge of the action to take if she is concerned about the welfare of a child. The childminder demonstrates a positive attitude towards keeping her knowledge up to date. She reads childcare literature and undertakes relevant courses. The childminder builds positive relationships with parents and others involved in children's care. She shares her observations and records of progress with parents and seeks their comments. This enables them to work in partnership to enhance children's learning opportunities.

## Quality of teaching, learning and assessment is good

The childminder creates an environment for children that she knows will interest them. Children explore and lead their own play. The childminder skillfully extends their skills. For example, children find items to cook in the play kitchen and serve them to the childminder. The childminder encourages language as she extends children's single words into simple sentences. She models good manners and children later copy her example, using please and thank you in their interactions. The childminder encourages mathematical language. For example, she refers to size, shape and quantity as she receives various plates of pretend food. The childminder encourages children to take an interest in the natural world. For example, they examine flowers, seeds and caterpillars in the garden.

### Personal development, behaviour and welfare are good

Regular communication with parents helps to ensure children's needs are understood. The childminder ensures children enjoy a stimulating day with some restful times, and regular meals and drinks. This helps to ensure children feel comfortable and enjoy their day with her. The childminder encourages parents to send healthy meals. She talks to children about their food and why it is good for them. Children learn about good hygiene routines and to be independent in preparation for school. The childminder takes children on outings in the local community, and shares carefully selected books to increase their awareness of our diverse society. The childminder uses language that helps children recognise their feelings. Children also learn about feelings and emotions, such as through stories and role play.

### **Outcomes for children are good**

Children develop the skills that will assist them in the next stage of their education. They are interested in everything around them and demonstrate increasing curiosity, independence and an eagerness to learn. Children enjoy making marks with pens and they listen to stories and talk about what they see in the picture books.
