Monitoring visit Inspected under the social care common inspection framework

Information about this children's home

This secure children's home is operated by a local authority and is approved by the Secretary of State to restrict young people's liberty. The home can accommodate up to 16 children aged between 10 and 17 years who are placed by local authorities under section 25 of the Children Act 1989.

Under section 25 of the Children Act 1989, admission of any child who is under 13 years of age requires the approval of the Secretary of State.

The commissioning of health services in this home is the statutory responsibility of NHS England under the Health and Social Care Act 2012. Education is provided on site in dedicated facilities.

The manager was registered with Ofsted in August 2017.

This monitoring visit

This children's home was judged to have declined in effectiveness at the interim inspection carried out on 14 February 2018. The purpose of this visit was to monitor the progress made in relation to the six requirements raised at the inspection.

6. The quality and purpose of care standard.

The quality and purpose of care standard is that children receive care from staff who understand the home's overall aims and the outcomes it seeks to achieve for children; and use this understanding to deliver care that meets children's needs and supports them to fulfil their potential.



In particular, the standard in paragraph (1) requires the registered person to ensure that the premises used for the purposes of the home are designed and furnished so as to enable each child to participate in the daily life of the home. (Regulation 6(1)(a)(b) and (2)(c)(ii))

The requirement stated that, in particular, the provider should repair the heating system and ensure that all areas of the home are suitably warm when used by children. Also, staff should ensure that high standards of cleanliness are consistently maintained throughout the home and should encourage and support children to take pride in their home, in particular their bedrooms.

The management of the home has not fully addressed this shortfall and therefore the requirement is repeated. While the heating in the home has been improved and repaired, the décor and cleanliness in some rooms and communal areas is poor. The garden has been poorly maintained and there are brambles and nettles in abundance which the children could take hold of, and which could cause injury to themselves or others. Graffiti in some of the rooms has not been removed, and some areas have been stained by food or drink which has been thrown on walls and not cleaned off. A food preparation area had cobwebs which had not been cleaned from walls, and there was dust in air grilles around the home. This lack of cleanliness undermines efforts made by members of staff to make the home feel welcoming and caring.

12. The protection of children standard.

The protection of children standard is that children are protected from harm and enabled to keep themselves safe.

In particular, the standard in paragraph (1) requires the registered person to ensure— that the home's day-to-day care is arranged and delivered so as to keep each child safe and to protect each child effectively from harm. (Regulation 12(2)(b))

The provider was asked in particular to ensure that the home's risk assessments include how staff should manage the potential risk when using portable heaters, including the individual risks posed to specific children.

This requirement has been fully addressed. Risk assessments are clear as to what steps to take if there is a need to use portable heating devices. Members of staff have a good awareness of potential risks to the children and how to manage them, especially with regards to self-harm. There has been no need to use portable heaters since the heating has been repaired.



13. The leadership and management standard.

The leadership and management standard is that the registered person enables, inspires and leads a culture in relation to the children's home that helps children aspire to fulfil their potential; and promotes their welfare.

In particular, the standard in paragraph (1) requires the registered person to use monitoring and review systems to make continuous improvements in the quality of care provided in the home. (Regulation 13(1)(a)(b) and (2)(h))

This was with particular reference to managers ensuring that they maintain oversight of day-to-day practice to make sure staff are maintaining high standards of care for young people.

This requirement has not been met and is being repeated. The monitoring of the decor and cleanliness in the home has not been effective. The daily checks carried out by staff, and overseen by managers, have failed to ensure that cleanliness and homeliness are maintained to a good standard. The monitoring system has lacked rigour and shortfalls have not been noted or addressed.

13. The leadership and management standard.

The leadership and management standard is that the registered person enables, inspires and leads a culture in relation to the children's home that helps children aspire to fulfil their potential; and promotes their welfare.

In particular, the standard in paragraph (1) requires the registered person to ensure that staff have the experience, qualifications and skills to meet the needs of each child. (Regulation 13(1)(a)(b) and (2)(c))

This was with specific reference to ensuring that prior to the use of agency staff, their experience, skills and employment history have been rigorously assessed to ensure that they are suitable to meet the needs of this complex, challenging and vulnerable group of children.

This requirement has been addressed. There has been considerable effort made to recruit suitable staff, and attention has been given to ensuring that they have the correct experience, skills and training to meet the needs of the children.

33. Supervision of staff.

The registered person must ensure that all employees receive practice-related supervision by a person with appropriate experience. (Regulation 33(4)(b))



This requirement is repeated. While records show that all members of staff receive regular supervision, the records fail to show that this is a meaningful process which considers whether key elements in the role are being explored or considered. Some records are brief and superficial and do not evidence that the supervision process is effective.

40. Notification of serious incidents to HMCI.

The registered person must notify HMCI and each other relevant person without delay if an incident requiring police involvement occurs in relation to a child which the registered person considers to be serious; or there is any other incident relating to a child which the registered person considers to be serious. (Regulation 40(4)(b)(e))

This requirement has been addressed. Managers in the home are swift to notify Ofsted of any events which they consider to be serious. This ensures that practice issues and information can be evaluated and shared with other agencies, such as the Department for Education.

During the visit, inspectors observed interactions between members of staff and children. These were friendly and relaxed, and it was clear that the children were at ease in the company of staff.

An inspector met with children to seek their views on living at this home. Feedback was very positive and the children said that they enjoyed staff company and felt safe. One child said that she would mark the home as '11 out of 10!', and reported that she does not want to leave. Another child, despite only being at the home for just over a week, named a number of staff whom she felt she could talk to and whom she seeks out for company.
