Summary of key findings for parents

This provision does not meet requirements

- Staff know the signs that indicate a child may be at risk of harm. However, leaders do not fully understand their responsibilities to keep children safe and what action to take when there are safeguarding concerns about children.
- Leaders have some records to evidence that some suitability checks have been completed for some staff. However, not all records are easily available, including staff vetting checks, to confirm staff are suitable to work with children.
- The setting's safeguarding policy does not outline the procedures to follow with regard to the use of mobile phones and cameras in the setting, as required.
- Leaders do not ensure that staff working with children have a valid paediatric first-aid certificate. Staff do not have a suitable understanding of how to deal with children's behaviour appropriately to help children learn how to behave well.
- Leaders do not know when to notify Ofsted of changes and significant events that have occurred in relation to the childcare provided. They do not have a suitable knowledge of the types of changes Ofsted need to be informed of.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What the setting needs to do to improve further

To meet the requirements of the early years foundation stage and Childcare Register the provider must:

- The inspector held discussions with the lead practitioner to assess how well leaders implement the statutory requirements.
- The inspector viewed a sample of documentation, such as policies, procedures and staff suitability checks.
- The inspector spoke to the lead practitioner about how the management team monitors and supports staff's performance.
- The inspector viewed parts of the premises which the after-school club use for childcare.
- The inspection was triggered as part of the risk assessment process.

Play With Us registered in 2005. It operates from the premises of Winsor Primary School in Beckton, in the London Borough of Newham. The club is open Monday to Friday, from 7.30am until 8.55am; and from 3.15pm until 6pm, during term time only. The holiday playscheme operates from 8am until 6pm. There are four members of staff employed to work with the children. Two staff hold appropriate early years qualifications.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
