- The manager and staff intend to complement the learning in school. They plan to support children to develop independence and confidence, and support them in managing tasks for themselves.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation.
