What does the children's home need to do to improve? Statutory requirements

Recommendations

- The child should be supported to sustain or regain their confidence in education and be engaged in suitable structured activities. ('Guide to the children's home regulations including the quality standards', page 28, paragraph 5.15) This is with particular reference to when children are excluded from education, that staff provide educational activities and seek work from the school for the child to complete.
- Staff should continually and actively assess the risks to each child and the arrangements in place to protect them. ('Guide to the children's home regulations including the quality standards', page 42, paragraph 9.5) This is with particular reference to the updating of risk assessments and risk management plans.

Inspection judgements

Overall experiences and progress of children and young people: good

Through the care that young people receive, they grow in confidence, develop socially and are helped to manage their emotions. They are given care that is highly sensitive to their individual needs and growing sense of identity. One young person described living at the home as 'being part of a family'.



Young people's lives are enriched through being supported to develop their talents and interests and they are given opportunities to take part in a wide variety of experiences. For example, both young people enjoyed a summer holiday abroad and one young person is competitively training in his chosen sport.

Relationships between the staff and young people are positive and warm. The genuine regard and understanding that young people receive help them grow in confidence and resolve any incidents that might occur.

Both young people attend education and are making progress against their starting points. One young person has developed a clear career plan for his future and is fully engaged in making this a reality.

When temporary exclusion from school has been necessary for a young person, there has, on occasions, been active liaison between the staff and the school. However, during the period of exclusion, staff did not ensure that the young person completed educational work.

Ongoing therapeutic support is offered to young people in a timely manner. This regular input complements and enhances the daily work and time that staff spend with young people.

How well children and young people are helped and protected: good

Young people do not engage in behaviours that would pose a risk to their welfare and safety, such as drug and alcohol misuse or criminality. Young people rarely go missing, and when this has occurred, it has been for short periods of time and staff were active in keeping in touch and locating them.

Young people feel a sense of safety through living at the home. This is underpinned by the manager and staff thoroughly understanding young people's vulnerabilities. Disclosures from young people are managed sensitively and in a child-focused way. Subsequent staff discussion regarding the safety and welfare of young people includes appropriate liaison and advice from the therapeutic clinical team.

Some risk assessment and risk management plans have not been updated following incidents or disclosures. The agreed staff responses and actions are therefore not clear to staff who may temporarily work in the home, such as staff from other homes within the company.

Staff establish healthy routines for young people and this supports every aspect of their lives. Over time, young people accept, understand and adhere to the boundaries and expectations that are put in place.

Staff manage incidents with young people through an individualised approach, and deescalation techniques are used effectively by the staff. Young people are encouraged to make positive choices and become more reflective in their responses.



The effectiveness of leaders and managers: good

The manager is appropriately qualified and experienced and has been registered to manage the home since September 2017. She is committed to achieving the right outcomes for young people and leads by example.

Staff receive good levels of support and advice from the manager. Young people are central to how the home is run and decisions that are made.

The manager is creative in her use of budgets, and this has ensured that young people enjoyed a high-quality and experience-filled holiday abroad. The planning of this involved young people, for example, saving amounts of weekly activity monies and running fund-raising events. This meant that the holiday was not limited by financial restrictions.

Staff turnover at the home is low and this provides stability to young people with regard to establishing and maintaining relationships. A team approach is adopted by staff and it is clear that they understand the goals and aspirations for young people. The manager and staff say that they feel 'proud' of their young people.

On the whole, information and documentation is kept up to date and evidences the progress that young people have made. However, some up-to-date key documentation, relating to care plans and pathway plans, has not been secured from the placing local authorities. These written plans are important to young people as they provide specific details of transition from the home and the services they can expect.

The manager and staff build and maintain good working relationships with other professionals. Information is shared appropriately and the manager seeks to ensure that care given is collaborative and holistic. However, not all serious incidents relating to the safety and welfare of young people have resulted in a notification to Ofsted. This limits the regulatory body's oversight of the home.

Information about this inspection

Inspectors have looked closely at the experiences and progress of children and young people. Inspectors considered the quality of work and the differences made to the lives of children and young people. They watched how professional staff work with children and young people and each other and discussed the effectiveness of help and care provided. Wherever possible, they talked to children and young people and their families. In addition, the inspectors have tried to understand what the children's home knows about how well it is performing, how well it is doing and what difference it is making for the children and young people whom it is trying to help, protect and look after.

Using the 'Social care common inspection framework', this inspection was carried out under the Care Standards Act 2000 to assess the effectiveness of the service, how it



meets the core functions of the service as set out in legislation, and to consider how well it complies with the Children's Homes (England) Regulations 2015 and the 'Guide to the children's homes regulations including the quality standards'.
