This provision meets requirements

- The manager and staff know how to protect children's welfare. For example, they are aware of the signs and symptoms that may cause them concern about a child's safety. They know local procedures to follow for reporting any concerns.
- Leaders value the importance of evaluating their service and keep up to date with childcare practices. For example, they regularly undertake 'quality visits' to maintain this good quality out-of-school service.
- The manager and staff understand the importance of working in partnership with parents and teaching staff at the host school to support children's overall care and learning needs.
- The manager knows how to promote children's learning well, including how she would plan varied and imaginative experiences to promote children's learning.
- The manager and staff know how to support children's healthy lifestyles well, for example, through regular exercise and healthy snacks at teatime.
- The manager demonstrates how she would promote children's positive behaviour, including how she would encourage them to respect one another, share and take turns.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector had a tour of the premises used for out-of-school care with the manager.
- The inspector discussed with the manager her understanding of Early Years Foundation Stage requirements.
- The inspector viewed relevant documentation, including public liability insurance, safeguarding procedures, and paediatric first-aid qualifications.
- The inspector checked evidence for the suitability of all staff.
