Summary of key findings for parents

The provision is inadequate

- The manager has not kept her safeguarding policy or knowledge up to date. She does not implement an appropriate safeguarding policy that is in line with the Local Safeguarding Children Board procedures. Staff do not know the correct procedure to follow in respect of allegations. This puts children at risk.
- Although ratios are met, staff are not consistently deployed effectively to supervise children at all times and to meet their individual needs.
- Staff do not consistently manage children's behaviour effectively to help them to learn what is expected of them.
- The manager does not evaluate or monitor the practice and teaching effectively to identify all areas for development and to improve the outcomes for children. She has not established a programme of professional development to help develop staff knowledge and skills and to raise the quality of teaching. As a result, the quality of teaching is variable and staff do not support children to make at least good progress.
- Systems for observation and assessment are not fully effective in identifying the progress that children make. Staff do not consistently focus planned activities sufficiently on what children need to learn next.

It has the following strengths

- Children have plenty of opportunities to develop their physical skills. Staff provide a suitable range of resources that helps children to develop small- and large-muscle skills.
- Staff provide healthy meals and snacks to help promote children's good health.

What the setting needs to do to improve further

To meet the requirements of the early years foundation stage and Childcare Register the provider must:

Inspection activities

- This inspection was carried out as a result of a risk assessment, following information received.
- The inspector observed the quality of teaching during activities inside and outdoors, and assessed the impact this had on children's learning.
- The inspector held a meeting with the provider and the nursery manager.
- The inspector discussed a range of policies and procedures and looked at evidence of the suitability of staff working in the nursery.
- The inspector spoke to staff, parents and children during the inspection and took account of their views

Inspection findings

Effectiveness of leadership and management is inadequate

The quality of care and learning has deteriorated significantly since the last inspection. Although the manager has completed some evaluation of the nursery, it is not focused and purposeful. She does not have an accurate overview of the overall quality and fails to identify significant weaknesses. Safeguarding is not effective. The manager does not implement an effective safeguarding policy in line with current Local Safeguarding Children Board guidance. Staff, including those who have the lead responsibility for safeguarding, are not aware of the correct procedure to follow in the event of allegations. Staff are not always deployed effectively. They do not consistently give their full attention to children. At times, they fail to notice when children are hitting or pushing each other. Sometimes, staff are not swift enough changing children out of wet clothes as they are waiting for other staff to assist. This has an impact on their ability to meet children's individual needs and on them being able to manage children's behaviour effectively. The manager does not monitor teaching or learning closely enough. She does not effectively support staff to identify gaps in learning at the earliest opportunity. As a result, children do not consistently make the progress of which they are capable.

Quality of teaching, learning and assessment requires improvement

All staff are qualified; however, this is not reflected in the overall quality of teaching, which is not strong enough. Staff carry out some observations and assessments of children's learning but they do not consistently complete them swiftly or accurately enough. Activities and experiences planned for children do not consistently focus sharply enough on what children need to learn next. At times, staff provide activities that are too difficult for children to understand. Children lose interest in activities and are easily distracted. At other times, suitable teaching strategies are used. For example, children enjoy collecting leaves in the nearby park. Staff encourage them to look at, and talk about, the different shapes, sizes and colours they can see.

Personal development, behaviour and welfare are inadequate

The weaknesses in leadership and management mean that children's welfare and safety are at risk. Staff are not consistent in reminding children of the rules and boundaries of the setting. Staff explain that the children follow 'golden rules'. However, children do not receive consistent messages from staff about these expectations. This means that children do not learn what is expected of them and how to keep themselves safe from harm. For example, staff say 'no', 'stop' or 'don't' without explaining why such behaviour is unacceptable. Children frequently run across the room without challenge from staff, despite there being a 'golden rule' to use 'walking feet'. Staff share regular information with parents. They speak to parents daily and invite them to regular meetings. This promotes some consistency of care. Children are generally settled and emotionally secure in the nursery.

Outcomes for children require improvement

Children make some steady progress from their starting points, but teaching is not strong enough to help them to reach their full potential. Children gain some confidence in the basic skills to help to prepare them for school.

Chestnut Tree Nursery registered in 2012. The nursery employs nine members of childcare staff, all of whom hold appropriate early years qualifications to at least level 2. The nursery opens Monday to Friday from 8am to 6pm all year round, with the exception of bank holidays. The nursery provides funded early education for two-, three- and four-year-old children.
