Summary of key findings for parents

This provision does not meet requirements

- Safeguarding is ineffective. The designated safeguarding person has still not attended a child protection training course. Actions from the previous inspection have not been fully met. The provider and the manager lack knowledge of the procedures to report concerns or what to do if an allegation is made against a member of staff or themselves. This is also a breach of the requirements of the Childcare Register. The provider has resigned from the Early Years Register but if they had not done so, Ofsted would have taken enforcement action.
- The manager is not aware of her duty to prevent children from being radicalised or being exposed to extremist views and opinions.
- The provider ensures that all staff working with the children are suitable to do so.
- The provider understands his responsibility to ensure children have access to a good range of resources and materials.
- The provider is aware of his responsibility to provide children with a nutritious and healthy diet.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What the setting needs to do to improve further

To meet the requirements of the early years foundation stage and Childcare Register the provider must:

Kidz Adventure Zone registered in 2008. The setting opens Monday to Friday from 3pm until 6.30pm, during term time. It also opens Monday to Friday during school holidays, from 8.30am until 6.30pm. The provider employs nine members of staff, including the manager. Of these, five hold appropriate childcare qualifications at level 2 and level 3.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
