**Overall outcome** 

The school does not meet all of the independent school standards that were checked during this inspection

# Main inspection findings

Part 1. Quality of education provided

Paragraph 3, 3(a), 3(c), 3(d), 3(f)

- The previous inspection found some weaknesses in teaching. Since then, staff have attended training and leaders have reviewed phonics teaching and have made changes to the way they check teaching and learning. Since October 2017, two teachers, including the deputy headteacher, have left the school and two new teachers have been appointed.
- Currently, the quality of teaching and learning in key stages 1 and 2 continues to have some shortcomings. In English, and to a lesser extent in mathematics, much work is targeted at the middle ability pupils. Consequently, there is insufficient challenge for the most able or support for those who find work difficult. This means some of the most able finish tasks quickly, while the less able pupils rely heavily on extra help or copying in order to complete work.
- In some lessons, resources are not ideal. During this inspection, for example, older pupils had to make do with a limited number of well-worn dictionaries to help them with a word identification activity. Some of the dictionaries did not contain the words to be checked. Furthermore, the most capable and articulate pupils completed the task quite quickly and had nothing more to push their learning on further.
- In another instance, low-quality worksheets of pictures of toys did not help younger pupils to gain a good understanding of old and new. In both cases, teachers had good intentions and the learning objectives were appropriate, but the available resources were not well matched to the tasks and this limited pupils' progress.
- At times, pupils repeat work they can already do. While staff recognise the importance of building pupils' fluency and recall, the inspector found several examples in lessons and pupils' books where pupils did not move on to more demanding work when they were ready to do so.
- The teaching of handwriting and spelling continues to require improvement. Too many pupils do not develop fluent and legible handwriting. Regular phonics teaching is helping to improve pupils' reading and spelling, but many pupils make simple errors because of weakness in their knowledge of how to spell words.



- On a positive note, the end-of-key-stage-2 test results for 2018 were an improvement on the standards reached in 2017. In mathematics, almost all pupils reached the expected standard for their age. In reading and writing, however, the proportions that reached the expected standard were still below the national averages. Over time, pupils' achievement in mathematics has been stronger than achievement in English.
- These standards are not met.

## Part 4. Suitability of staff, supply staff, and proprietors

Paragraphs 17, 18(1), 18(2), 18(2)(a), 18(2)(b), 18(2)(c), 18(2)(c)(i), 18(2)(c)(ii), 18(2)(c)(iii), 18(2)(c)(iii), 18(2)(d), 18(2)(e)

- The inspection in October 2017 did not identify any unmet standards under Part 4. However, as a routine part of this inspection, the inspector examined the single central record of checks on staff. The inspector checked the record against a current staff list and against government records of prohibition from teaching and section 128 direction checks. Since the previous inspection, one member of staff has been issued with an interim prohibition from teaching order. This has been recorded correctly in school and school leaders are following the advice they have been given. That said, there is no system in place for trustees other than the headteacher to check the school's arrangements.
- The single central record complies with requirements.
- These standards are met.

#### Part 6. Provision of information

- The previous inspection found that information for parents was not readily available via the school's website. Since then, the school has created a more reliable website that is easy to navigate and contains all the required information. This includes the school's safeguarding policy, which was last revised in September 2018 to take account of the government's most recent statutory guidance.
- In addition to being published on the school's website, policy statements for admissions, behaviour, the use of exclusion, complaints, special educational needs (SEN) and provision for pupils who speak English as an additional language are available to parents from the school's office. These policies meet requirements, although the documents describing support for pupils who speak English as an additional language and the policy statement for SEN and/or disabilities are brief and contain the bare minimum of information.
- These standards are met.



## Part 8. Quality of leadership in and management of schools

Paragraphs 34(1), 34(1)(a), 34(1)(b)

- The proprietor and school leaders are still not demonstrating the necessary knowledge and expertise to ensure that all of the independent school standards are met consistently. While leaders have ensured that the standard relating to the provision of information is now met, they have not managed to make any sustained improvements to teaching. The current quality of teaching does not enable pupils to make good progress, especially in English.
- During this inspection, it was evident that leaders have sought external advice and have acted upon it. However, they remain heavily dependent on such advice in order to lead and manage the school.
- This standard is not met.



# **Compliance with regulatory requirements**

The school does not meet the requirements of the schedule to The Education (Independent School Standards) Regulations 2014 ('the independent school standards') and associated requirements that were checked during this inspection, as set out in the annex of this report. This included the standards and requirements that the school was judged to not comply with at the previous inspection. Not all of the standards and associated requirements were checked during this inspection.

#### Information about this school

- Birmingham Muslim School is an independent Islamic day school for girls and boys aged four to 11 years old. It was opened in 2001.
- There are currently 72 pupils on roll.
- No pupils have been identified as having SEN and/or disabilities.
- The proprietor is The Albayan Education Foundation Ltd. This is made up of a board of three trustees, one of whom is the headteacher.
- The headteacher does not have a class teaching commitment.
- Since the previous inspection, two teachers, including the deputy headteacher, have left the school and two new teachers have been appointed.







# Information about this inspection

- This inspection was carried out at the request of the registration authority for independent schools. The purpose of the inspection was to monitor the progress the school has made in meeting the independent school standards and other requirements that it was judged to not comply with at its previous inspection.
- This inspection was carried out with no notice and lasted one day.
- This was the first monitoring inspection since the school's action plan was evaluated by Ofsted on 14 February 2018 and found not to be acceptable. The Department for Education rejected the action plan on 12 June 2018.
- The inspector visited every room in the school building and checked the outdoor playground. He examined the single central record of checks on staff and sought advice from the teaching regulation agency about their recent communication with the school.
- The inspector held meetings with the headteacher and other staff. In addition, he spoke to pupils and staff in classrooms, observed teaching and learning and looked at pupils' work in books. He looked at records of staff training and information produced by an external educational consultant. He also looked at books in the school's recently opened library.
- During the inspection, the proprietor was represented by the headteacher. Neither of the other trustees were available.
- Before the inspection, the inspector checked the school's website and looked at Parent View, where there were 27 recent responses.
- The inspection was quality assured by a Senior Her Majesty's Inspector.
