Summary of key findings for parents

This provision meets requirements

- The manager is aware of his duty to safeguard children and protect them from harm. He and his staff are aware of the procedures to follow should they have any concerns for a child's welfare.
- The manager recognises the importance of evaluating and developing the setting. He is proactive in continuing to advance his own skills and knowledge and those of his staff.
- The manager explains how he values partnerships with parents and the school that children attend. He appreciates the need to ensure that opportunities offered within the club complement those that children participate at home and school.
- The manager discusses the methods he would use to promote positive behaviour. He understands the need to encourage children to have good manners and to learn respect and tolerance towards each other.
- The manager outlines his understanding of the need to encourage children to develop a healthy lifestyle. He appreciates the need to offer children opportunities to play in the fresh air and to eat healthy and nutritious food.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector had a tour of the rooms to be used by the club. She discussed and viewed resources that will be available to children.
- The inspector checked evidence of the suitability of all staff.
- The inspector discussed and reviewed relevant documentation, such as a range of policies and procedures and training certificates of staff.
- The inspector discussed with the manager how he intends to keep parents informed of the activities that their children enjoy while at the club.

Superstars Long Clawson registered in 2016. The club employs two members of staff. Of these, one holds an appropriate early years qualification at level 3. The club opens from Monday to Friday, term time. Sessions are from 7.30am until 8.40am and from 3pm until 6pm.
