# Information about this children's home

This privately owned children's home is registered to provide care and accommodation for up to five children. The statement of purpose states that the home accommodates children aged eight to 18 who are deemed to require help in a residential specialist resource.

The manager has been registered with Ofsted since 2008.

# This monitoring visit

This monitoring visit was carried out following the restriction notice that began on 22 August 2018. The purpose of this monitoring visit was to ensure that the provider had remained compliant with the restriction of accommodation notice that expires on 14 November 2018. The inspector also sought evidence to demonstrate whether the provider had met the requirements made at the full inspection on 15 and 16 August 2018.

The inspector met with the acting manager, and one director. No young people have moved into the home since the last inspection. Therefore, the provider is compliant with the restriction of accommodation notice. Relevant records were examined, and a tour of the premises was conducted.

The registered manager remains absent from work. The responsible individual is leaving the company, and one of the directors is in the process of registering for the role.

At the previous full inspection, a requirement was made regarding the whistleblowing policy. The policy has been updated and now provides staff with clear guidance on whistle-blowing, what to report, to whom and when. Staff showed that they are familiar with the policy, and have read and understood it.



The director and staff have reviewed the home's statement of purpose. Frequent staff meetings have been utilised as an opportunity to underpin the staff's understanding of how to deliver care in practice. Staff spoke of feeling well supported and clear about the objectives set by leaders and managers. Regular communication from leaders and managers further supports the staff in delivering consistent, predictable care.

One young person is living at the home. The consistent team approach has provided him with boundaries that he is unable to flex. As a result of this, he has developed improved communication skills and understands that staff can keep him safe.

The home's safer recruitment process has been reviewed. Leaders and managers found significant shortfalls in previous recruitment checks. This resulted in a staff member who was banned from driving being able to drive company vehicles. No notification was made regarding this, nor was the Disclosure and Barring Service (DBS) informed. Changes in practice include two staff signing off the checks to ensure that no new staff are approved to begin work until the relevant checks are completed satisfactorily.

Leaders and managers are utilising team meetings to share knowledge and develop new formats. A good example of this is the team members working together on a referral. Through this practical experience they identified gaps in the impact assessment and used this learning to develop a new format. The team members have experienced a sense of achievement as a result of successfully developing new practices together.
