Summary of key findings for parents

This provision does not meet requirements

- Older children bring and use their mobile phones in the setting. The provider and staff lack understanding of the mobile phone policy and do not follow this to safeguard children.
- The provider has not ensured the staff have up-to-date knowledge and understanding of safeguarding issues. In particular, how to recognise children at risk of radicalisation and extremist behaviours. This puts children's welfare at risk.
- The provider is not able to evidence that staff on site are suitable to work with children and fails to ensure any ongoing suitability.
- The provider does not regularly supervise staff to ensure their ongoing professional development.
- The provider has failed to ensure Ofsted has been kept informed of significant events that affect the childcare service.
- The provider does not ensure staffing arrangements meet the needs of the children at all times.
- Children are settled and enjoy their activities.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What the setting needs to do to improve further
