## Summary of key findings for parents

### This provision meets requirements

- The childminder describes how he intends to meet with his co-childminder's and assistants regularly to work together and effectively plan for each child. He talks about how he will share information with them and keep them up to date with any changes in practice or guidelines.
- The childminder describes how he will help children to prepare for school. He talks about how he will help children to be independent and manage small tasks on their own.
- The childminder demonstrates a good understanding of children's developmental and emotional needs. He describes how he will encourage good behaviour and support children's healthy lifestyles.
- The childminder describes how he intends to teach children how to manage their own risks and safety. He plans to teach children how to keep safe when crossing roads and how to keep the environment safe and tidy during play.
- The childminder recognises the importance of evaluating his practice and describes how he intends to seek the views of his assistants, parents and children to help him identify ways to improve the setting.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

### **Inspection activities**

- The inspector viewed the premises used for childminding.
- The inspector and childminder discussed his knowledge of safeguarding, risk assessment procedures, child development and self-evaluation.
- The inspector reviewed the resources and talked to the childminder about how he would plan activities to support children's learning.
- The inspector sampled documentation, including planning, policies and procedures.

The childminder registered in 2005. He lives in Merstham, Surrey. The childminder has a childcare qualification at level 3 and cares for children between 8am and 6pm, Monday to Friday, all year round. The childminder works with two other registered childminders and three assistants.
