Summary of key findings for parents

This provision meets requirements

- The leadership team demonstrates a secure understanding of their role and responsibility to safeguard and protect children from harm. They have a secure knowledge of local safeguarding procedures and know how to identify and report concerns they may have. Staff are appropriately trained to follow the club's safeguarding procedures.
- The leadership team has a sound understanding of how to complement children's learning in school. They provide a range of stimulating activities and experiences to promote children's enjoyment.
- The leadership team is dedicated and hard-working. They are knowledgeable and well qualified. They recognise the value of evaluating their practice to help to identify their strengths and areas for development and improve outcomes for children.
- The leadership team recognises the importance of working with parents, other settings and professionals to promote and provide a consistent approach to children's care and learning.
- The leadership team helps children to learn expectations for behaviour and promotes children's well-being. They identify that this supports children's self-esteem and confidence.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the leadership team how they intend to deliver the educational programme for children.
- The inspector discussed the policies and procedures with the leadership team and viewed the documentation that they use when caring for children.
- The inspector viewed the areas of the premises used by children and discussed the equipment and resources available.
- The inspector discussed the safeguarding and welfare requirements with the leadership team.
- The inspector discussed how the leadership team evaluates their practice and work in partnership with parents.

Twilight Hours registered in 2010. The club employs 14 members of staff. Of these, six hold appropriate early years qualifications at level 3, and one holds a qualification at level 4. The club is open Monday to Friday from 7.30am to 8.40am and 3.30pm to 6pm, during term time and for three weeks in the main school holiday.
