Summary of key findings for parents

The provision is good

- Parents report very positively about the care and support provided by the childminder. The childminder has recently developed further ways to encourage fathers to be more involved in her setting, which has had a positive impact on families.
- The childminder reflects on her practice very well. She has recently worked with other childminders in reviewing their teaching techniques. This has helped her to accurately assess and target areas for her own development.
- The childminder regularly reviews children's progress and uses what she knows to plan activities for areas in which children require a bit more support. This ensures they remain consistently challenged and enjoy new experiences.
- Children are very independent and enjoy having additional responsibility. Older children approach babies for a gentle hug during play, helping them to feel safe, secure and valued.

It is not yet outstanding because:

- The childminder does not successfully encourage all parents to be involved in monitoring their child's progress and supporting continued learning at home.
- Although children enjoy learning about different cultures and hearing other languages spoken, the childminder has not fully considered how she can represent the cultures of all children attending her setting.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- explore further ways of encouraging parents to be involved in their child's learning and provide support for how they can extend this at home
- extend ways of recognising and celebrating all of the different cultures and backgrounds of the children attending.

Inspection activities

- The inspector observed activities and care routines indoors and outdoors.
- The inspector held discussions with the childminder and interacted with the children at appropriate times.
- The inspector conducted a joint observation with the childminder.
- The inspector reviewed written parental feedback to gather their views.
- The inspector reviewed a sample of records and documentation.

Inspection findings

Effectiveness of leadership and management is good

Safeguarding is effective. The childminder supervises children very well. She reminds children about taking care, while allowing them to take appropriate risks during play. She understands the procedures to follow if she has concerns about a child and plans to further update this in the future. The childminder works extremely closely with parents, seeking key information about children's routines and following these as closely as possible when children first attend. She has experience of working with other professionals and has attended further training on how to support children who have special educational needs and/or additional needs, which has helped to increase her confidence and skills further. The childminder reflects carefully on all aspects of her provision. She takes on board parents' ideas and works closely with others to review her practice. The childminder has recently developed how she assesses children's learning, which has enabled her to clearly see any gaps in children's progress and take steps to close them quickly.

Quality of teaching, learning and assessment is good

Children receive lots of interaction as they play. They enjoy being challenged to think about how things work. The childminder asks lots of open questions, giving sufficient time for them to think through their ideas before responding. Children's language and communication skills are particularly well supported. Babies are developing the sounds needed to start speaking. The childminder supports this through repeating their sounds and encouraging them to babble. She plans interesting and age-appropriate activities that all children, including the babies, explore for long periods. Their strong engagement shows they are enjoying their learning and concentrating well.

Personal development, behaviour and welfare are good

Children are very independent. Toddlers feed themselves confidently and enjoy making choices, such as what coloured bowl to choose from the cupboard, and what fruit to eat for a snack. The childminder respects each individual child and knows their personalities and interests very well. Children enjoy having regular access to the garden, where they jump on the trampoline, and explore wheeled toys. The childminder supports and encourages babies as they begin to take some steps. Children behave very well and beam as they receive praise and encouragement for being kind to their friends. They have developed very close relationships with other children and the childminder, showing they feel extremely secure and safe in her care.

Outcomes for children are good

Children are making very good progress in their learning and are developing the skills required for school. They engage for long periods and concentrate hard as they practise new skills and work out problems. They are confident and self-assured, and respond well to challenges. They enjoy using their natural curiosity during activities and are developing high levels of self-esteem.
