Summary of key findings for parents

The provision is good

- Staff build strong partnerships with other settings that children attend and professionals involved in children's lives. They communicate effectively to ensure all children receive the support they need to make good progress in their learning and development.
- Children have excellent opportunities to respect and understand the similarities and differences of people in the wider world. They thoroughly enjoy an extensive range of interesting activities, for example, learning about Spanish traditions. Staff support children who speak English as an additional language particularly well.
- Parents are fully involved in their children's learning from the start. They report positively on the support nursery staff offer them and their children.
- Children enjoy the time they spend in the nursery. Staff offer plenty of cuddles and reassurance and new children settle very quickly.
- The manager and staff are committed to providing the best quality play and learning environment they can for children. They have an accurate view of the quality of the provision and identify areas for further development successfully.

It is not yet outstanding because:

- The manager has not fully developed effective supervisory sessions with staff to raise the quality of teaching to an even higher level.
- Arrangements for monitoring progress do not focus sharply on identifying any differences in the progress made by different groups of children.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- strengthen the arrangements to support and supervise staff and focus even more effectively on enhancing the already good teaching
- develop systems to monitor the progress different groups of children make, to help ensure all children continue to make good progress in their learning and development.

Inspection activities

- The inspector spoke to the manager and other staff at appropriate times throughout the inspection.
- The inspector completed a joint observation with the deputy manager.
- The inspector observed children's indoor and outdoor play, snack and lunch times and hygiene routines.
- The inspector checked various documents including risk assessments, a range of policies and procedures and evidence of the suitability of staff working in the nursery.
- The inspector spoke to parents during the inspection and considered their views.

Inspection findings

Effectiveness of leadership and management is good

Safeguarding is effective. Staff have a secure knowledge of how to identify and respond to any concerns about a child's welfare. They deploy themselves well and implement effective risk assessments to protect children from harm. This helps them to maintain a safe environment for children. Overall, the manager implements an effective safeguarding policy. She provides induction for new staff, training and support for all staff to undertake childcare qualifications. This helps staff to understand their role.

Quality of teaching, learning and assessment is good

Staff gather relevant information from parents about what their children already know, can do and need to learn next. They use this information along with their ongoing observations to establish children's starting points and support their learning effectively. Staff provide engaging activities to meet the needs and interests of individual children. Children are keen and enthusiastic learners. They follow instructions well and are familiar with the daily routines. Children's language development is fostered well. For example, staff play alongside children and comment on what they are doing. They spend time talking and listening to children to help build on their speaking skills. Young children enthusiastically sing a wide range of songs and rhymes. Children enjoy reading books and listening to stories read by enthusiastic staff. They are actively involved in the story and use visual props to help tell it. They independently choose books to read and handle them with care.

Personal development, behaviour and welfare are outstanding

Children behave impeccably and they are incredibly polite. Children have outstanding opportunities to challenge their physical skills, such as using more-complicated equipment, including an assault course. All children are extremely independent and confident. They enthusiastically explore their surroundings. For instance, toddlers discover natural objects with interest and excitement. Children skilfully serve themselves during mealtimes. Siblings spend time together every day. They visit each other and excitedly share lunchtime together in the school hall. Children show increasingly high levels of confidence in social situations. All children develop a positive sense of self, and of their place in the world.

Outcomes for children are good

Children play collaboratively and welcome others into their games. Younger children demonstrate good mathematical skills. For instance, during play with toy animals, they hold one up in the air and state, 'I found a small one'. Toddlers develop good sensory skills. They enjoy experiences, such as feeling the texture of sand as it runs between their fingers. All children make good progress and acquire skills that help to prepare them for future learning and school.
