- The provider understands the benefits of working in partnership with parents and other professionals to help provide consistency in meeting children's specific needs.
- The provider understands how to help children learn about healthy lifestyles, such as being active and choosing healthy foods.
- The provider ensures children can freely choose from a wide range of activities and resources.
- The provider understands how to help children learn to respect each other and how to promote children's good behaviour.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Fireflies After School Club registered in 2016 and is privately owned. The club employs 12 members of staff, two of whom hold appropriate childcare qualifications at level 2 and above, including the manager who holds a childcare qualification at level 3. The club operates during school term time only. Breakfast club is from 7.30am to 8.30am and after-school club is from 3pm to 6pm each week day.
