Summary of key findings for parents

This provision does not meet requirements

- The provider was unable to produce records of Disclosure and Barring Service checks for staff members to demonstrate the appropriate checks had been carried out to ensure staff are suitable to work with children.
- The provider was not able to demonstrate the qualifications of staff, in relation to first aid, as documentation was unavailable for inspection.
- The provider does not have robust systems to identify why children have had numerous injuries and why staff are not consistently aware of how these have happened. This compromises children's safety and welfare.
- Leaders and staff demonstrate an understanding of child protection issues and have an appropriate policy to help protect the children in their care. Staff know what to do if they have any concerns about a child's well-being.
- The manager and staff know how to meet children's individual needs and interests to ensure children have access to a wide range of resources and materials.
- The manager and staff understand how to support good behaviour and help children to be considerate and respectful of others. They recognise the importance of supporting children's understanding of diversity and of healthy lifestyles.
- The manager is aware of the importance of working in partnership with parents and with the staff at the host school. She knows how to encourage two-way communication with parents and teachers regarding children's experiences and welfare.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What the setting needs to do to improve further

To meet the requirements of the early years foundation stage and Childcare Register the provider must:
