Summary of key findings for parents

This provision meets requirements

- The provider has successfully addressed the action set at the last inspection to ensure that at least one member of staff holds a valid paediatric first-aid qualification.
- Staff know how to carry out risk assessment to identify any potential hazards and remove or minimise these to promote the welfare and safety of children.
- The provider maintains mandatory documentation, such as attendance registers and accident records. She demonstrates that they follow appropriate recruitment and vetting procedures to ensure that staff are suitable to work with children.
- Staff have a suitable knowledge of safeguarding. They understand the signs and symptoms that could indicate a child is at risk of harm and are aware of what to do if they need to report their concerns.
- The provider understands the importance of working in partnership with parents and the school to promote consistency in children's care and learning.
- Staff recognise the benefits of providing children with healthy snacks and daily opportunities to gain fresh air and take part in physical exercise.
- The provider knows how to promote children's positive behaviour and understands the importance of setting clear boundaries for children to follow.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector spoke to the provider, manager and staff about the provision of care for the children and had a tour of the areas used by the children at the club.
- The inspector held discussions with the provider. She checked evidence of the suitability of staff working with the children.
- The inspector sampled a range of documentation, including policies and procedures, staff records and risk assessment.

Northants Kids Club registered in 2015. The club employs two members of childcare Staff. They open from Monday to Friday term time from 3.15pm until 5.50pm and from 8am until 6pm during the school holidays.
