Summary of key findings for parents

This provision does not meet requirements

- Staff understand reporting procedures for safeguarding, however, they are unclear on potential signs and symptoms that a child may be at risk of abuse or from extreme views or behaviours. This puts children at risk.
- Staff are not able to demonstrate how they manage children's behaviour appropriately. They do not understand how to use positive strategies to manage children's behaviour.
- Staff demonstrate that they understand how to meet children's individual needs. They plan activities according to themes using children's interests to help to make them fun and enjoyable.
- Staff work in partnership with parents. They gather their views and use these to shape services they provide. Recent suggestions from parents have been to use more of the centre's services, such as the pool and martial art classes. They now use these for children to take part in. This helps to support children's time at the club.
- There are appropriate arrangements in place to provide first-aid treatment and to maintain the require records.
- Leaders are fully aware of their roles in contacting Ofsted to report changes to senior staff within the club.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What the setting needs to do to improve further

To meet the requirements of the early years foundation stage and Childcare Register the provider must:

Erith Leisure Centre, also known as Camp Adventure, is a holiday playscheme and registered in 2005. It is located within Erith Sports Centre in the London Borough of Bexley. The playscheme operates each weekday during Easter, summer and all half term school holidays, between the hours of 8am and 6pm. Three staff work directly with the children and, of these, one has a relevant early years qualification to level 3.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register.
