- The childminder knows how to keep children safe. She understands how to report concerns about a child's welfare. She knows how to use risk assessments to keep her home free from hazards.
- The childminder understands how children learn. She understands how to use assessments of children's learning to plan activities that will support their progress. She knows how to work with other settings children attend to share information and prepare children for the move to school.
- The childminder knows how to evaluate her work. She understands how to seek the views of children and parents to identify areas of improvement. She values professional development opportunities and knows how to continually improve her skills.
- The childminder understands the importance of creating an inclusive and happy setting for children. She knows how to manage their behaviour positively and teach them about the world around them. The childminder understands how to promote diversity and provide children with opportunities to learn the importance of kindness and respect.
- The childminder knows how to engage children of different ages in purposeful learning. She understands how to use the indoor and outdoor areas to develop children's skills.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector looked at all parts of the childminder's house that will be used for childcare.
- The inspector held meetings with the childminder to establish her understanding of the requirements of the early years foundation stage.
- The inspector sampled the childminder's documentation, including policies and procedures and information related to safeguarding and children's learning.
- The inspector asked the childminder questions to find out how she intends to work with parents and other settings that children attend.

The childminder registered in 2008. She lives in Leyton, in the London Borough of Waltham Forest. She operates on weekdays, between 7am and 6.30pm throughout the year, except for bank holidays and family holidays. The childminder is registered to provide free early years education for children aged two, three and four years.
