## Summary of key findings for parents

#### This provision meets requirements

- The childminder describes how she keeps an up-to-date knowledge of childcare practices. She demonstrates she has a good understanding of protecting children from harm and neglect and the reporting procedures she must follow in the event of a concern.
- The childminder demonstrates how she works in partnership with parents. She describes how she encourages parents to tell her all about their child and their wishes for their child's care during the settling-in procedures.
- The childminder understands the learning and development requirements. She describes how she supports children's development by planning a range of activities to support their progress in the seven areas of learning.
- The childminder discusses how she tracks and monitors children's development. She describes how she uses this information and makes an assessment about what children can do.
- The childminder discusses how she supports children's overall health. She describes how she plans for children to spend time outside and be physically active.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

#### **Inspection activities**

- The inspector viewed the areas of the childminder's home that are used for childminding.
- The inspector discussed with the childminder how she plans to meet the requirements of the early years foundation stage and promote children's progress.
- The inspector checked a range of documentation, including the suitability checks of adults living and working on the premises, training certificates and policies.
- The inspector spoke with the childminder throughout the inspection.

The childminder registered in 1992 and lives in Coventry. The childminder operates all year round from 8am to 6pm, Monday to Friday, except for bank holidays and family holidays.
