This provision meets requirements

- The childminder keeps up to date with early years foundation stage developments. For example, she completes online courses, reads relevant documentation and shares information with other professionals to help keep her knowledge and skills current.
- The childminder reviews her practice and provision effectively. She has taken positive steps to make improvements since the previous inspection.
- The childminder acknowledges the importance of building good relationships with parents, including the importance of sharing information about children's learning and development.
- The childminder recognises the significance of monitoring children's individual progress. She knows how information gathered through assessments can be used to plan for their next steps and identify any emerging gaps in their development.
- The childminder is aware of her role in keeping children safe and protecting them from risk of harm. She knows the procedure to follow if she is concerned about the well-being of a child.
- The childminder recognises her role in teaching children about good hygiene routines, setting clear boundaries and learning to respect and value others.
- The childminder understands her role in supervising and monitoring her assistant, including, ensuring he has up-to-date safeguarding knowledge.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector looked at the areas of the home used by children.
- Discussions were held with the childminder about practice, especially how she assesses children and provides suitable learning activities and experiences for them.
- The inspector checked required documentation, such as a paediatric first-aid certificate and evidence of public liability insurance.
- The inspector asked the childminder questions throughout the inspection to establish her understanding of the statutory requirements.
